### House Bill 569 Sponsor Testimony

Chair Johnson, Vice Chair Cirino, Ranking Member Martin, and members of the Higher Education and Career Readiness Committee, thank you for the opportunity to provide sponsor testimony on House Bill 569- The Hidden Heroes Scholarship Act. As State Reps, our bills frequently include legislation that revolves around one of three questions- How do we lower barriers to higher education? How do we improve access to quality healthcare? How to do we support and give back to veterans who have sacrificed their physical and mental health in service to our nation? HB 569 is a bill that addresses all three questions simultaneously.

House Bill 569 authorizes both public and state universities in Ohio to create the Hidden Heroes Scholarship Program. This voluntary, university funded program will cover the education costs of family members caring for 100% service-connected disabled veterans. The bill allows universities to provide 100% last dollar tuition waivers, pay stipends, and grant college credits to scholarship recipients. Because this program will be optional and funded by each participating university, it comes at no additional cost to Ohio taxpayers and imposes no mandate in terms of minimum or maximum amounts universities must put toward the program.

With over 900 enrolled VA caregivers in the state, House Bill 569 has the potential to impact hundreds of veteran families. That is why universities and veterans' organizations are excited about this bill. This legislation received overwhelmingly positive feedback in IP meetings and from house members in both parties. Seeing the excitement reinforces how much
