A BILL

То	enact section 2307.931 of the Revised Code to	1
	require a plaintiff in a tort action alleging an	2
	asbestos claim to file specified disclosures.	3

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 2307.931 of the Revised Code be	4
enacted to read as follows:	5
Sec. 2307.931. (A) As used in this section, "each	6
exposure" means every exposure to asbestos or an asbestos-	7
containing product by an exposed person or by a person through	8
whom the exposed person was exposed to asbestos.	9
(B) The plaintiff in any tort action who alleges an	10
asbestos claim shall file, within thirty days after filing any	11
complaint, a sworn statement signed by the plaintiff or the	12
plaintiff's counsel, specifying the evidence that provides the	13
basis for each asbestos claim against each defendant in the	14
action. The sworn statement is in addition to any other	15
requirements for asbestos claims under sections 2307.91 to	16
2307.98 of the Revised Code and shall include all of the	17

following with specificity:		
(1) The name, address, date of birth, marital status,	19	
occupation, smoking history, current and past worksites, and	20	
current and past employers of the exposed person and any person	21	
through whom the exposed person was exposed to asbestos;	22	
(2) The name, address, and relationship to the exposed	23	
person of each person who is knowledgeable regarding the exposed	24	
<pre>person's exposures to asbestos;</pre>	25	
(3) The manufacturer and seller and the specific name of	26	
each asbestos-containing product, including, but not limited to,	27	
all brand and trade names of that specific asbestos-containing	28	
product, to which the exposed person was exposed or to which the	29	
other person was exposed if the exposure was through another	30	
<pre>person;</pre>	31	
(4) For each exposure to an asbestos-containing product	32	
identified under division (B)(3) of this section, each site and	33	
the specific location at each site, including the address of	34	
each site, where the exposed person was exposed or where the	35	
other person was exposed if the exposure was through another	36	
person;	37	
(5) The beginning and ending dates of each exposure, the	38	
specific manner of each exposure, the frequency and length of	39	
each exposure, and the proximity of the asbestos-containing	40	
product or its use to the exposed person and to each person	41	
through whom the exposed person alleges exposure to asbestos;	42	
(6) The specific asbestos-related disease that is alleged;	43	
(7) Any supporting documentation relating to the	44	
information required under division (B) of this section.	45	

(C) A plaintiff in a tort action alleging an asbestos	46
claim has a continuing duty to supplement the information that	47
is required to be disclosed under division (B) of this section,	48
including when the plaintiff receives new exposure history	49
information or becomes aware that a prior disclosure was	50
inaccurate or incomplete.	51
(D) The plaintiff shall not commence discovery against a	52
defendant in a tort action alleging an asbestos claim until the	53
defendant's product or premises is specifically identified in	54
the disclosures required under division (B) of this section.	55
(E)(1) A defendant whose product or premises is not	56
specifically identified in the disclosures required under	57
division (B) of this section, or who believes the plaintiff's	58
disclosures fail to comply with division (B) of this section,	59
may file a motion with the court to administratively dismiss the	60
plaintiff's claim against that defendant. The plaintiff shall	61
have thirty days from the date of the filing of the defendant's	62
motion to file disclosures that comply with division (B) of this	63
section or otherwise respond to the defendant's motion.	64
(2) The court shall administratively dismiss a plaintiff's	65
asbestos claim against a defendant who files a motion under	66
division (E)(1) of this section or as to all defendants, as	67
applicable, if the plaintiff's disclosures fail to comply with	68
division (B) of this section.	69
(F) A claim that is administratively dismissed pursuant to	70
division (E) of this section is dismissed other than upon the	71
merits for purposes of section 2305.19 of the Revised Code.	72
(G) This section applies to a tort action alleging an	73
asbestos claim that is filed on or after the effective date of	74

this section.		
(H) This section does not apply to a claim for workers'	76	
compensation or a claim for veterans' benefits.	77
