H.B. No. 477- Sponsor Testimony

Chairman Holmes, Ranking Member Baker, and Members of the House Aviation and Aerospace Committee: thank you for the opportunity to provide testimony on H.B. 477. This legislation will aim to incorporate seaplane bases, heliports, vertiports, and spaceports into the Aeronautics Law.

The proposed legislation before this committee aims to achieve several critical objectives:

Firstly, it seeks to establish clear definitions of key terms such as "heliports," "vertiports," and "spaceports," integrating these definitions seamlessly into Ohio's Aeronautics Law. By doing so, we provide clarity and coherence to the regulatory landscape, creating an environment favorable to the growth of AAM infrastructure.

Secondly, the legislation mandates that any seaplane base, heliport, vertiport, or spaceport intended for commercial use must obtain a certificate of approval from the Department of Transportation (ODOT). This requirement ensures that all AAM facilities meet rigorous standards of safety and operational integrity before being utilized for commercial purposes.

Finally, this legislation applies consistent processes and requirements, similar to those imposed on commercial airports, to all AAM facilities seeking ODOT certification. This uniform approach guarantees equitable treatment and adherence to established regulatory norms across the board.

In conclusion, this legislation represents a pivotal step forward in Ohio's journey to become a national and international leader in the AAM industry. By creating an environment of innovation, safety, and regulatory clarity, we pave the way for the continued growth and success of Ohio's AAM initiatives.
