Chairman Johnson, Vice Chair Manchester, Ranking Member McNally, and members of the House Commerce & Labor Committee:

I'm writing to voice my company's support for House Bill 327. My name is Ric Bonfiglio Senior Vice President for Lake Erie Electric. Our company has been in operation in Ohio and surrounding states since 1952, and we currently have 8 offices across our state. I'm proud to say that throughout our years in business, we have become a leader in our highly competitive markets, providing electrical construction services to industry leaders in the power generation and energy sector, the manufacturing and industrial sector, and in Ohio's emerging high-tech and mission-critical sectors.

Lake Erie Electric provides this testimony in support of House Bill 327. By requiring E-Verify employment verification use by a very specific segment of non-residential construction contractors operating in the state of Ohio, HB 327 levels the playing field for Ohio-based businesses that operate in compliance with existing immigration and labor law.

Our company uses E-Verify, an internet-based system that is jointly administered by the United States Department of Homeland Security and Social Security Administration, to determine new employees' employment eligibility. It is user-friendly system for human resources and hiring staff; E-Verify simply automates and expedites existing hiring verification processes. E-Verify is free for companies to use.

Across the state of Ohio, in every market in which Lake Erie Electric competes, we have for years worked hard to overcome the unfair advantage of companies that exploit and traffic undocumented workers. HB 327 protects our company's ability to operate in fair and free competition in full compliance with immigration and labor law.

I believe that the narrow requirements of HB 327 provide reasonable protections for law-abiding nonresidential construction contractors and vulnerable workers who are at risk of exploitation by labor traffickers. This bill provides a reasonable solution for Ohio business owners and the public.
