### **Opponent Testimony**

Good morning Chairman Plummer and Members of the House Constitutional Resolutions Committee, my name is Anisa Liban and I serve as the Government Affairs Director at CAIR-Ohio. The Council on American Islamic Relations is the largest Muslim Civils Rights organization in the nation -- Its Ohio Chapter serves thousands of Ohioans in Central Columbus, Cincinnati and Cleveland.

I am here today in opposition of House Joint Resolution 1 and to urge members of the committee to prioritize the people of Ohio who have vocalized their concerns with this unpopular and unnecessary proposal.

For over 111 years, Ohioans have resided in this great state with the freedom to mobilize and petition for amendments to the Ohio constitution.

This proposal would not only overturn a century-old right, but would directly impact residents like me who work hard to engage and educate disenfranchised minority communities on a wide-range of topics, including voter education and know-your-rights resources.

This resolution is honestly terrifying. For a moment, can you imagine the unnecessary stress placed on a working parent, elder or student when they are informed that their ballot signature does not match or meet new requirements & they have no opportunity to cure their signature?

Or the unnecessary burden placed on organizers to obtain signatures from at least 5% of electors of each county, instead of half of the counties?

This resolution negatively impacts Ohioans' access to direct democracy and dismisses the voices of countless residents whose votes will not be considered as a result of this minority-rule mindset.

If an amendment is going to apply to **every Ohioan**, I believe then every community should have a say in putting that potential constitution amendment on the ballot.
