Interested Party Testimony, House Bill 33 (Edwards)

Chair Edwards, Vice Chair LaRe, Ranking Member Sweeney, and members of the House Finance committee, thank you for the opportunity to provide Interested Party Testimony on House Bill 33 (HB33), regarding the state's Main Operating Budget for Fiscal Years 2024 and 2025.

My name is Mark Holtsberry, President of the Paulding County Board of Commissioners (Commissioners) and the Vice President of the Paulding County Land Reutilization Corporation. I am submitting written testimony on behalf of the Commissioners. The commissioners oversee county activities and work to ensure citizen concerns are met. The Commissioners recognize and support the work of the Paulding County Land Reutilization Corporation, and know the work being done positively effects our county. Rehabilitating brownfield properties of potentially significant value but that are otherwise non-productive due to abandonment and returns or recirculates these properties back into productive use through a transparent, public, and community-oriented process.

Recognizing the challenge presented to Ohio by the presence of brownfields, the FY22-23 main operating budget established the Brownfield Remediation Fund (BRF), providing \$350 million to assess and cleanup these environmentally contaminated sites. We commend the Legislature for the inclusion of this program, and the Ohio Department of Development in its administration of this successful program.

The Brownfield Remediation Fund's \$350 million provided grants to 313 projects in 83 of Ohio's 88 counties. While this is a significant investment in the assessment and cleanup of brownfields, the need remains for grant dollars to remediate and redevelop these blighted brownfields into productive use.

The as-introduced budget does not include funding for the Brownfield Remediation Fund, and therefore, we are writing to encourage the committee to provide an additional \$350 million to this program in the FY24-25 budget.

Paulding County Land Reutilization Corporation has three brownfield properties on the list of 125 projects that were granted assessment dollars. Without additional funding, our Sunoco Gas Station in Antwerp, Ohio, Grizzley Brake, and Stokely Properties near Paulding will likely remain contaminated. Adding to the concern, while working on these assessment projects, PCLRC identified more brownfields in Paulding County that need assessment and cleanup dollars. Please assist us in the vital role of promoting revitalization, renewal, and community pride.

An additional investment of \$350 million to this program will allow the 125 projects including ours that received an assessment to compete for cleanup dollars. In addition to these 125 projects, the need for brownfield grant dollars remains. The final round for applications through ODOD opened and closed in less than three business days due to limited funding remaining and an overwhelming number of

applications. Knowing how blighted properties in a neighborhood can impact the value of other properties and can result in a downward spiral of disrepair, foreclosure, and vacancy in a neighborhood, and thinking there would be additional funding made available in 2024, PCLRC started investing in outreach and research. Without the additional cleanup money, projects may not move forward.

Chair Edwards, Vice Chair LaRe, Ranking Member Sweeney, and members of the House Finance committee, thank you for your time and attention to this important issue. I am happy to answer any questions you may have.
