Several years ago I was discouraged and felt that there was no possible way to reign in the overreaching federal bureaucracy. Washington DC and its agencies seemed determined to control every facet of our lives. I was without hope until I read a book called *The Liberty Amendments*. I now recognize that the only way to curtail DC's overreach was to call for a Convention of States for the purpose of limiting the authority and scope of the Federal Government.

Some people who discern the same problems I do are afraid of holding a convention of states. Some of these people would rather have anarchy and civil unrest leading to armed revolution. Some prefer the route of secession. Many think it is enough to keep electing people to Federal office and hope that they do not become corrupted by the power, money and influence.
