

Chairman Cutrona, Vice Chair Gross, Ranking Member Somani, and members of the Health Provider Services Committee, thank you for allowing me to provide support testimony for **HB 319; “The Conscientious Right to Refuse Act.”**

It is vital for we the people and farmers retain the right to decline any vaccine or drug that violates our conscience or our religion without facing discriminatory action now and in the future, as well as in pandemics.

The vaccine definition was changed, as this gene therapy mandated across the country was not a ‘vaccine’; as many doctors report. The CDC changed its definition of vaccine from “a product that stimulates a person’s immune system to produce immunity to a specific disease, protecting the person from that disease” to “a preparation that is used to stimulate the body’s immune response against diseases.” Vaccines do not have to produce immunity. We are now finding out childhood vaccinations did not have thorough trials.

Vaccination definition has been changed to “The act of introducing a vaccine into the body to produce protection from a specific disease. The latest CDC definition is absent the word “immunity” and just focuses on the stimulation of the body’s immune response. “The previous definition...could be interpreted to mean that vaccines were 100% effective, which has never been the case for any vaccine, so the current definition is more transparent.” The definition of vaccination was also changed by a public health agency.

The CDC is changing definitions on “fully vaccinated”. “Administration of an additional primary dose or a booster dose is not required to be considered fully vaccinated for public health purposes *at this time*”. Yet, they are constantly rolling out and advocating for boosters to the public.

*Vaccines may not give 100% immunity*, so it should be up to individuals on whether to take them. Vaccines for covid-19 were not 100% effective and were experimental and forced mandates and violates our first amendment rights. The test and studies on these were not thorough and transparent to the public. In coordination with government and democrat owned social media organizations, doctors that spoke up giving ivermectin, zinc, high doses of vitamin D and C and other protocols that worked were censored from the public. Doctors knew past SARS and the protocols that worked. Mr. Fauci and Birx did not disclose these remedies. It was a 1 sided case to take the vaccines. If there were other options, then the vaccines would not be allowed,

and the preplanned pandemic could not happen. It was a coordinated effort from the top. Many documents have come out that this was a planned event and “vaccinations” existed in 2019 for covid-19. The government paid pharmaceutical companies for vaccines, yet no portion of the billions in profits were refunded back to the government. It’s a big network that was funded by us.

My college athlete was subjected to constant testing for covid-19 in order to participate. I knew that PCR was not an accurate tool from Kary Mullis himself, the inventor. I let the University know on facebook group and was banned. PCR testing needs to be Stopped for cattle and chickens, which is why I added farmers. There is a takeover of the US with covid policies to lead the change as well as censorship.

Policies restricted our travel across the border with vaccination to get back in the country, which is health discrimination<sup>2</sup>.

Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.

*The people* have certain natural *rights* which are *retained* by them when they enter into Society, Such are the rights of Conscience in matters of religion; of acquiring property and of pursuing happiness & Safety; of Speaking, writing and publishing their Sentiments with decency and freedom; of peaceably assembling to consult their common good, and of applying to Government by petition or remonstrance for redress of grievances. Of these rights therefore they Shall not be deprived by the Government of the United States.

We the people need to be watch dogs over the government.

Ohioans should have their right of conscience and religion protected from the State, medical over-reach of employers, or those providing public services. Both the U.S. and Ohio State constitutions address the right of conscious and religious freedom. It is time to make sure that those freedoms are protected at the state level.
