Dear Chairman Bird:

I am an Ohio homeschool educator. This letter serves as my response to proposed legislative changes in HB 12 and SB 1.

Please adopt the language as recommended by the Christian Home Educators of Ohio Association which clarifies that homeschooled students are "exempt" and not "excused" in the Ohio Revised Code. I have attached their language recommendations to this letter.

It is my understanding that Sub. SB 1 has been reassigned to a different committee. If you are able to have any continued influence through conversations with Chairman Swearingen, please convey that it's still important to remove the paragraph that subjects home educated students to the state truancy statute. This amendment added by the Senate makes no sense.

Thank you for your attention to this important detail.

**RC 3321.042 in substitution for lines 45173 through 45190 on p. 1554**

(A)(1) Home education means the education of a child, between six and eighteen years of age, that is directed by the child's parent, as defined by 3321.01 of the Revised Code. It does not include education provided to a child who is enrolled full time in a public or chartered nonpublic school.

(2) A child receiving home education in the subject areas of English language arts, mathematics, science, history, government, and social studies is exempt from the provisions of section 3321.04 of the Revised Code.

(3) Within 5 calendar days after the commencement of home education, or within 5 calendar days after moving into a new school district, or within 5 calendar days after withdrawal from public or chartered nonpublic school enrollment, and by August 30th annually thereafter, the parent or guardian shall transmit a notice to the superintendent of the school district in which the child resides. The notice shall provide the parent's name and address, the child's name, and an assurance the child will receive education in the subjects required under this section. The exemption is effective

immediately upon receipt of the notice. The superintendent shall acknowledge receipt of the notice to the parent in writing within 14 calendar days. The child exempt under this section shall not be required to be excused under section 3321.04 of the Revised Code.

(B) A child that is being enrolled in a public school following any period of home education shall be placed in the appropriate grade level, without discrimination or prejudice, based on the policies of the school district in which the child is being enrolled.

(C) This section shall not be subject to regulations promulgated pursuant to Chapter 119 of the Ohio Revised Code.
