Chair Lipps, Vice Chair Stewart, Ranking Member Liston, and Members of the Public Health Policy Committee:

My name is Erin Upchurch, my pronouns are she/her. I am a parent of two young adults, an independently licensed social worker and former therapist in the state of Ohio, and the Executive Director of [Kaleidoscope Youth Center](#); Ohio's largest and longest standing organization to serve and support LGBTQIA+ youth and young adults ages 12-24.

I am writing to express absolute opposition to HB 68.

**HB 68 is blatant discrimination.** This bill unnecessarily targets transgender and non-binary youth, their families, and allied providers and health professionals. HB 68 politicizes the lives of young people in Ohio, with zero regard for their health and well-being; and is an egregious misuse of power, and a breach of public trust in caring for the youth of Ohio.

**As an independently licensed social worker,** this bill is in direct opposition to the National Association Social Work [Values and Code of Ethics](#), such as self determination, informed consent, privacy and confidentiality, and commitment to clients.

**This bill compromises the rights of parents/guardians** by disrupting their ability to care for and make evidence-based healthcare decisions that are best for their children, with the guidance of experienced and licensed medical providers.

Currently, the [Ohio revised code indicates](#) that minors aged 14 and up can consent to their own mental health treatment without consent or knowledge of the minor's guardian (as long as it does not include treatment with medication). **This legislation denies the already determined best practices of mental health treatment and care.**

Elected officials stripping away the autonomy of parents and children to make the kinds of medical decisions that would be best for them is absurd. **Sponsors and proponents of this bill are grossly out of scope**, which means they are making recommendations and medical decisions for others that are outside of their expertise and education. In most professions, this type of practice is considered unethical.


