The Chair called House Resolution 198 for its fourth hearing. No witnesses came forward to testify. The Chair called on Vice Chair Dobos who moved that the House Transportation Committee favorably report House Resolution 198 out of Committee. The clerk called the roll. House Resolution 198 was favorably reported with a vote of ten yeas and three nays. This concluded the fourth and final hearing for House Resolution 198.

The Chair called House Bill 224 for its first hearing. Representative Joe Miller and Representative Mary Lightbody were present and gave sponsor testimony. They then answered questions from the Committee. This concluded the first hearing for House Bill 224.

The Chair called House Bill 286 for its first hearing. Representative Santucci was present and gave sponsor testimony. The Chair called on Vice Chair Dobos who moved that the House Transportation Committee favorably report House Bill 286 out of Committee. The clerk called the roll. House Bill 286 was favorably reported with a vote of thirteen yeas and zero nays. This concluded the first and final hearing for House Bill 286.

The Chair called House Bill 294 for its first hearing. Representative Beth Lear and Representative Brian Lorenz were present and gave sponsor testimony. The Chair called upon Vice Chair Dobos who motioned to amend House Bill 294 with amendment number 1335. Without objection, amendment 1335 was approved by the Chair and became part of House Bill 294. The Chair called upon Vice Chair Dobos who moved that the House Transportation Committee favorably report House Bill 294 out of Committee. The clerk called the roll. House Bill 294 was favorably reported with a vote of thirteen yeas and zero nays. This concluded the
