Testimony, HB 119-Designate Dr. Steven Takacs Memorial Highway Bill

Chairman McClain, Vice Chair Ferguson, Ranking Member Grim, and members of the Transportation Committee,

Thank you for hearing sponsor testimony on House Bill 119, legislation that will dedicate a portion of Route 87 in Geauga County to an extraordinary man, Dr. Steven Takacs. This is a re-introduction of House Bill 469, introduced by Representative Diane Grendell in the 134th General Assembly.
