You may either send the information to us through the mail or complete the questionnaire electronically by going to <a href="tax.ohio.gov">tax.ohio.gov</a> and clicking on the Self Help eLibrary at the bottom of the page. Click Section Five, Vehicle Taxes Help and then Downloads and Electronic Forms. Once you submit the questionnaire, click the link and an email will be created allowing you to attach and send to us additional documentation.

If a tax liability is determined to be due after we review the requested documentation, you will be notified accordingly.

Online payments are not available for this program. If the exemption was claimed in error, please submit your payment of \$1,476.40 by check or money order payable to the Treasurer - State of Ohio by June 15, 2023. Please include the Contact ID # 1542234846 on the memo line along with a copy of this notice.

Failure to respond with payment in full or supporting documentation that will clear this obligation by June 15, 2023 will result in the issuance of an assessment for the calculated tax due, plus applicable penalties and interest.
