Chairman Brenner, Vice Chair O'Brien, Ranking Member Ingram, and committee members, my name is Christina Collins. I have been elected to the State Board of Education since January 1, 2021. Once again, thank you for the opportunity to express my views through written testimony today.

Enacting SB 1 now will disenfranchise the 225,871 voters who voted for me. In addition, it will silence the input of stakeholders and give special interest more influence over our education policy.

During last week's testimonies, Chairman Brenner asked Board Member Tom Jackson, who has only been on the Board for a few weeks, "What are you doing as a Board member to improve the lives of the schools and the students in that district?"

Yours is a great question, and it is one I believe everyone involved with policy in education should be asking. Therefore, to inform myself, this committee, and the public, I combed through the last two year's Board meeting minutes to better understand what the Board has done.

Since January 2021, the Board has acted on hundreds of personnel items, appointments to various boards, territory transfer cases, and payment-in-lieu of transportation disputes. The actions of the Board rest in power vested to it through Ohio Revised Code (3301.07) and involve the overall leadership of Ohio's education system. Although many rules and resolutions have been passed, I will highlight those most pertinent to answering Senator Brenner's question.

These can generally be categorized into five areas:

- 1. Raising Student Achievement
- 2. Responding to COVID
- 3. Weighing in on Legislation
- 4. Implementing Legislation
- 5. Overseeing the Ohio Department of Education

Below are the titles of associated resolutions and their vote count, passage date, and essential language or notes.
