- 4. Compliance with NFPA Standards: The legislation mandates that protective door assemblies in school buildings adhere to the standards outlined in the 2015 NFPA 101. This provision ensures that schools have robust security measures in place, including panic hardware, fire exit hardware, electricity-controlled egress doors, and other protective door assemblies. Compliance with these standards significantly enhances the overall security posture of our educational facilities.
- 5. Improved Emergency Response: The Ohio Childhood Safety Act will significantly enhance the ability of law enforcement agencies to respond effectively and swiftly to emergencies in school buildings. By ensuring that protective door assemblies are in compliance and undergo regular inspections, first responders will have expedited access to critical areas during emergencies, minimizing response times and potential risks to students, educators, and staff.

6. • Streamlined Police Operations: The legislation provides law enforcement with greater confidence in the security infrastructure of school buildings. Knowing that protective door assemblies have been inspected and tested by qualified inspectors, police officers can focus their attention on addressing the emergency situation at hand without unnecessary delays or complications related to accessing secured areas.

The FOP views the Ohio Childhood Safety Act as a crucial step in ensuring the security and well-being of students, educators, and staff within our school buildings. By enacting this legislation, Ohio will demonstrate its commitment to creating a safe and secure learning environment that promotes optimal educational outcomes.

We urge you to support and advance the Ohio Childhood Safety Act, recognizing the paramount importance of life safety and security in our school buildings. By approving this legislation, Ohio will demonstrate its commitment to safeguarding our educational institutions and creating a secure future for our students.
