I appreciate the opportunity to provide testimony on this harmful bill. My name is Ross Widenor, and I am the Council President and Ward 1 Council Member for the City of Munroe Falls. The testimony herein is submitted on behalf of me and the undersigned community leaders.

Teachers have an important job to do. They prepare children with the knowledge they need to operate in the world. HB8 seeks to muzzle teachers from accurately representing the range of individuals and families that they will encounter, and possibly identify with, in society. Same-gender couples exist. Transgender people exist. No child is "protected" from anything by attempting to force teachers to pretend otherwise.

On the other hand, LGBTQ+ children are very much harmed by not seeing themselves represented in their curriculum and getting the message that they need to hide and repress themselves in order to be acceptable. The harm to LGBTQ+ children goes further through the provision forcing the disclosure of the fact that a child may be in a questioning phase regarding their sexual orientation or gender identity. Look no further than the statistics that LGBTQ+ youth are 120% more at risk of homelessness and up to 40% of total unaccompanied unhoused youth are LGBTQ+ to see why not everyone rushes to come out to their parents.
