# BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF OHIO:

WHEREAS, A Norfolk Southern train carrying hazardous	6
materials derailed in East Palestine, Ohio on February 3, 2023;	7
and	8
WHEREAS, At the time of its derailment, the train was not	9
considered a high-hazard flammable train by the United States	10
Department of Transportation; and	11
WHEREAS, Ten of the 50 railroad cars that derailed	12

contained chemicals such as vinyl chloride, butyl acrylate,	13
ethylhexyl acrylate, and ethylene glycol monobutyl, all of which	14
are dangerous to life and the environment; and	15
WHEREAS, As a result of the derailment, the hazardous	16
chemicals have contaminated the air and water of East Palestine,	17
forcing its residents to live in fear for their health; and	18
WHEREAS, The State of Ohio was not aware that a train	19
carrying such hazardous materials was traversing through the	20
state; and	21
WHEREAS, The federal government should inform local and	22
state government officials when trains carrying potentially	23
hazardous materials travel through their respective	24
jurisdictions; now therefore be it	25
RESOLVED, That we, the members of the House of	26
Representatives of the 135th General Assembly of the State of	27
Ohio, urge the United States Congress to pass legislation	28
requiring railroad companies to inform local and state	29
government officials when trains, similar to the one that	30
derailed in East Palestine, carrying potentially hazardous	31
materials travel through their respective jurisdictions; and be	32
