The Senate met pursuant to adjournment.

Prayer was offered by Father Michael Lumpe, Christ the King Catholic Church, Columbus, Ohio, followed by the Pledge of Allegiance to the Flag.

The journal of the last legislative day was read and approved.

REPORTS OF REFERENCE AND BILLS FOR SECOND CONSIDERATION

Senator Schuring reports for the Standing Committee on Reference, recommending that the following bills and concurrent resolutions, standing in order for second consideration, be referred to committee as recommended:

S. B. No. 118-Senator Gardner.

Cosponsors: Senators Coughlin, Miller, D., Mumper, Boccieri, Spada, Grendell.

To amend sections 3301.0718, 3313.60, 3313.603, 3314.03, and 3314.21 and to enact sections 3314.40 and 3319.076 of the Revised Code to require daily physical education instruction in grades kindergarten to six, to require completion of one unit of physical education in grades seven to twelve, to require physical education teachers to be licensed in their subject area, and to make other changes relative to physical education.

To the Committee on Education.

S. B. No. 119-Senator Schuler.

Cosponsor: Senator Schuring.

To amend sections 323.25, 323.31, 323.67, 5721.06, 5721.10, 5721.13, 5721.14, 5721.18, 5721.25, 5721.31, 5721.34, 5722.01, 5722.02, 5722.05, 5722.06, 5722.07, 5722.08, 5722.10, 5722.14, 5722.15, 5722.21, and 5723.06, to enact new sections 5722.03 and 5722.04, and to repeal sections 323.77, 5722.03, 5722.04, and 5722.13 of the Revised Code to modify the tax-delinquent land reutilization law by authorizing political subdivisions to prosecute property tax foreclosures, acquire such land through foreclosures before the land is offered at a tax sale, and sell such property at less than appraised market value; and to impose a one-year limit on property owners' option to obtain a delinquent tax installment payment contract.

To amend sections 5111.011 and 5111.0118 and to enact section 5111.182 of the Revised Code to establish a Medicaid program for individuals who exhaust benefits under a qualified long-term care insurance policy.

S. B. No. 122-Senator Miller, D.

To amend section 122.075 and to enact section 5537.29 of the Revised Code to establish a schedule for E85 blend fuel to be made available at service stations located on the Ohio Turnpike and to permit the Ohio Turnpike Commission to apply for grants made by the Department of Development under the Alternative Fuel Transportation Grant Program.

To amend sections 117.13 and 131.02 and to enact sections 117.60 to 117.72 of the Revised Code to require the Auditor of State to contract with independent audit consultants to recover overpayments made by certain state agencies to vendors.
