	turkey without procuring a deer or wild turkey	4

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 1533.12 of the Revised Code be	6
amended to read as follows:	7
Sec. 1533.12. (A)(1) Except as otherwise provided in	8
division (A)(2) of this section, every person on active duty in	9
the armed forces of the United States who is stationed in this	10
state and who wishes to engage in an activity for which a	11
license, permit, or stamp is required under this chapter first	12
shall obtain the requisite license, permit, or stamp. Such a	13
person is eligible to obtain a resident hunting or fishing	14
license regardless of whether the person qualifies as a resident	15
of this state. To obtain a resident hunting or fishing license,	16
the person shall present a card or other evidence identifying	17
the person as being on active duty in the armed forces of the	18

United States and as being stationed in this state.	19
(2) Every person on active duty in the armed forces of the	20
United States, while on leave or furlough, may take or catch	21
fish of the kind lawfully permitted to be taken or caught within	22
the state, may hunt any wild bird or wild quadruped lawfully	23
permitted to be hunted within the state, may hunt deer or wild	24
turkey lawfully permitted to be hunted within the state, and may	25
trap fur-bearing animals lawfully permitted to be trapped within	26
the state, without procuring a fishing license, a hunting	27
license, a deer or wild turkey permit, a fur taker permit, or a	28
wetlands habitat stamp required by this chapter, provided that	29
the person shall carry on the person when fishing, hunting, or	30
trapping, a card or other evidence identifying the person as	31
being on active duty in the armed forces of the United States,	32
and provided that the person is not otherwise violating any of	33
the hunting, fishing, and trapping laws of this state.	34
In order to hunt deer or wild turkey, any such person-	35
shall obtain a deer or wild turkey permit, as applicable, under-	36
section 1533.11 of the Revised Code. However, the person need	37
not obtain a hunting license in order to obtain such a permit.	38
(B) The chief of the division of wildlife shall provide by	39
rule adopted under section 1531.10 of the Revised Code all of	40
the following:	41
(1) Every resident of this state with a disability that	42
has been determined by the veterans administration to be	43
permanently and totally disabling, who receives a pension or	44
compensation from the veterans administration, and who received	45
an honorable discharge from the armed forces of the United	46
States, and every veteran to whom the registrar of motor	47
vehicles has issued a set of license plates under section	48

4503.41 of the Revised Code, shall be issued a fishing license, hunting license, fur taker permit, deer or wild turkey permit, or wetlands habitat stamp, or any combination of those licenses, permits, and stamp, free of charge on an annual, multi-year, or lifetime basis as determined appropriate by the chief when application is made to the chief in the manner prescribed by and on forms provided by the chief.

- (2) Every resident of the state who was born on or before December 31, 1937, shall be issued an annual fishing license, hunting license, fur taker permit, deer or wild turkey permit, or wetlands habitat stamp, or any combination of those licenses, permits, and stamp, free of charge when application is made to the chief in the manner prescribed by and on forms provided by the chief.
- (3) Every resident of state or county institutions, charitable institutions, and military homes in this state shall be issued an annual fishing license free of charge when application is made to the chief in the manner prescribed by and on forms provided by the chief.
- (4) Any mobility impaired or blind person, as defined in section 955.011 of the Revised Code, who is a resident of this state and who is unable to engage in fishing without the assistance of another person shall be issued an annual fishing license free of charge when application is made to the chief in the manner prescribed by and on forms provided by the chief. The person who is assisting the mobility impaired or blind person may assist in taking or catching fish of the kind permitted to be taken or caught without procuring the license required under section 1533.32 of the Revised Code, provided that only one line is used by both persons.

Any person who has been a prisoner of war, was honorably	84

(C) The chief shall adopt rules pursuant to section	92	
1531.08 of the Revised Code designating not more than two days,	93

fishing days" on which any resident may exercise the privileges	95	
accorded the holder of a fishing license issued under section	96	
1533.32 of the Revised Code without procuring such a license,	97	
provided that the person is not otherwise violating any of the
