To enact section 4503.434 of the Revised Code to
establish the "Distinguished Flying Cross"
license plate.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4503.434 of the Revised Code be enacted to read as follows:

Sec. 4503.434. (A) Any person who has been awarded the distinguished flying cross may apply to the registrar of motor vehicles for the registration of any passenger car, noncommercial motor vehicle, recreational vehicle, or other vehicle the person owns or leases of a class approved by the reqistrar. The application shall be accompanied by such 11 documentary evidence in support of the award as the registrar 12 shall require by rule. The application may be combined with a 13 $\begin{array}{ll}\text { request for a special reserved license plate under section } & 14\end{array}$ $\begin{array}{ll}4503.40 \text { or } 4503.42 \text { of the Revised Code. } & 15\end{array}$
