BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4503.491 of the Revised Code be	4
amended to read as follows:	5
Sec. 4503.491. (A) The owner or lessee of any passenger	6
car, noncommercial motor vehicle, recreational vehicle,	7
motorcycle, or other vehicle of a class approved by the	8

registrar of motor vehicles may apply to the registrar for the 9 registration of the vehicle and issuance of breast cancer 10 awareness license plates. An application made under this section 11 may be combined with a request for a special reserved license 12 plate under section 4503.40 or 4503.42 of the Revised Code. Upon 13 receipt of the completed application and compliance by the 14 applicant with divisions (B) and (C) of this section, the 15 registrar shall issue to the applicant the appropriate vehicle 16 registration and a set of breast cancer awareness license plates 17 and a validation sticker, or a validation sticker alone when 18 required by section 4503.191 of the Revised Code. 19

In addition to the letters and numbers ordinarily inscribed on the license plates, breast cancer awareness license plates shall be inscribed with identifying words or markings that promote breast cancer awareness and are approved by the registrar. Breast cancer awareness license plates shall display county identification stickers that identify the county of registration by name or number.

(B) The breast cancer awareness license plates and a 27 validation sticker, or validation sticker alone, shall be issued 28 upon receipt of a contribution as provided in division (C) of 29 this section and upon payment of the regular license tax as 30 prescribed under section 4503.04 of the Revised Code, any 31 applicable motor vehicle license tax levied under Chapter 4504. 32 of the Revised Code, any applicable additional fee prescribed by 33 section 4503.40 or 4503.42 of the Revised Code, a fee of ten 34 dollars for the purpose of compensating the bureau of motor 35 vehicles for additional services required in the issuing of 36 breast cancer awareness license plates, and compliance with all 37 other applicable laws relating to the registration of motor 38
