**A BILL**

To enact sections 5534.01, 5534.02, 5534.05,  
5534.06, and 5534.25 of the Revised Code to  
designate a memorial highway within the city of  
Sandusky and to designate memorial interchanges  
and a memorial pedestrian bridge in Erie County.

**BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:**

**Section 1.** That sections 5534.01, 5534.02, 5534.05,  
5534.06, and 5534.25 of the Revised Code be enacted to read as  
follows:

**Sec. 5534.01.** The interchange of the road that carries the  
designations of both United States route number six and state  
route number two and Rye Beach road located in the municipal  
corporation of Huron shall be known as the "Sgt. James C.  
Fekete, SF Memorial Interchange."

The director of transportation may erect suitable markers 14  
at the interchange indicating its name. 15

**Sec. 5534.02.** The interchange of the roads known as state 16  
route number two and state route number thirteen located in 17  
Huron township in Erie county shall be known as the "FN James C. 18  
Baumer, USN Memorial Interchange." 19

The director of transportation may erect suitable markers 20  
at the interchange indicating its name. 21

**Sec. 5534.05.** The interchange of the roads known as state 22  
route number two and Berlin road located in Huron township in 23  
Erie county shall be known as the "Sgt. Terrance R. Mesenburg, 24  
USA Memorial Interchange." 25

The director of transportation may erect suitable markers 26  
at the interchange indicating its name. 27

**Sec. 5534.06.** The pedestrian bridge spanning the road 28  
known as United States route number six, located in the 29  
municipal corporation of Huron and having a northern terminus of 30  
south Jim Campbell boulevard and a southern terminus of Adams 31  
avenue, shall be known as the "Sgt. Michael W. Finke, Jr. 32  
U.S.M.C. Memorial Walkover." 33

The director of transportation may erect suitable markers 34  
upon the bridge or its approaches indicating its name. 35

**Sec. 5534.25.** In addition to any other name prescribed in 36  
the Revised Code or otherwise, that portion of the road known as 37  
United States route number six, commencing at the intersection 38  
of that route and state route number four and proceeding in an 39  
easterly direction to the intersection of that route and Cedar 40  
Point drive, within the municipal corporation of Sandusky only, 41  
shall be known as the "Army Specialist Charles E. Odums II 42

Memorial Highway." 43

The director of transportation may erect suitable markers 44  
along the highway indicating its name. 45
