BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 3333.27 of the Revised Code be	7

Sec. 3333.27. (A) As used in this section:	9
(1) "Academic year" shall be defined by the chancellor of	10
the Ohio board of regents.	11
(2) "Community college" has the same meaning as in section	12
3354.01 of the Revised Code.	13
(3) "Eligible student" means an undergraduate student who:	14
(a) Is enrolled in a certificate program or an associate	15
degree program at a community college, state community college,	16
or technical college;	17

(b) Is a resident of this state, as defined by the	18
chancellor under section 3333.31 of the Revised Code;	19
(c) Is making satisfactory academic progress, as defined	20
by the financial aid office, or the equivalent, at the college	21
in which the student is enrolled;	22
(d) Has attained and maintains a cumulative grade point	23
average of at least 2.0 on a 4.0 scale, or the equivalent;	24
(e) Has obtained a high school equivalence diploma on or	25
after the first academic year that begins after the effective	26
date of this section.	27
(4) "High school equivalence diploma" has the same meaning	28
as in section 5107.40 of the Revised Code.	29
(5) "State community college" has the same meaning as in	30
section 3358.01 of the Revised Code.	31
(6) "Technical college" has the same meaning as in section	32
3357.01 of the Revised Code.	33
(B) The chancellor shall establish and administer the GED	34
grant program to provide grants to eligible students in the	35
amount of two hundred fifty dollars per student per semester,	36
for not more than four semesters, that the student is enrolled	37
in a certificate program or undergraduate program at a community	38
college, state community college, or technical college. The	39
chancellor shall adopt rules under Chapter 119. of the Revised	40
Code to administer the program.	41
(C) The number of grants awarded under the program for an	42
academic year shall not exceed the number that can be funded	43
with appropriations made by the general assembly for this	44
