BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF OHIO:

WHEREAS, The national housing crisis that began in 2007 led	5
to unprecedented home price declines and sustained and higher	6
unemployment in certain parts of the country, including Ohio;	7

WHEREAS, Families in these areas, including Ohio, struggled	9
to make their monthly mortgage payments and to get out from	10
under deeply underwater mortgages; and	11
WHEREAS, In 2008, Save the Dream Ohio was created as a	12
multi-agency foreclosure prevention outreach initiative	13
involving partners from state government, nonprofit housing	14
counseling agencies, and legal aid organizations to address this	15

crisis; and	16	
WHEREAS, In 2010, the Ohio Housing Finance Agency received	17	
\$570.4 million from the United States Department of the	18	
Treasury's Hardest Hit Fund to administer Ohio's foreclosure	19	
prevention program through Save the Dream Ohio; and	20	
WHEREAS, Save the Dream Ohio has worked with 32 United	21	
States Department of Housing and Urban Development-approved	22	
nonprofit counseling agencies and over 350 mortgage servicers	23	
nationwide to provide assistance to over 24,000 homeowners at	24	
risk of foreclosure; and	25	
WHEREAS, An additional \$60 million was designated for	26	
the Neighborhood Initiative Program to stabilize property	27	
values and prevent future foreclosures by removing and	28	
greening vacant and blighted properties; and	29	
WHEREAS, Save the Dream Ohio had to stop accepting	30	
applications in August 2014, and payments on behalf of	31	
homeowners are expected to end in late 2016; United States	32	
Department of the Treasury guidelines specify that funds must	33	
be dispersed by December 31, 2017; and	34	
WHEREAS, The Ohio Housing Finance Agency continues to	35	
administer the Save the Dream Ohio hotline to connect	36	
homeowners with HUD-approved housing counseling agencies and	37	
other resources; now therefore be it	38	
RESOLVED, That we, the members of the House of	39	
Representatives of the 131st General Assembly of the State of	40	
Ohio request the Congress of the United States to renew	41	
funding for Save the Dream Ohio through the United States	42	
Department of the Treasury's Hardest Hit Fund, to continue to	43	
provide assistance to homeowners in the state of Ohio at risk
