**A R E S O L U T I O N**

To request the Congress of the United States renew 1  
funding for Save the Dream Ohio to help 2  
homeowners in the state of Ohio avoid 3  
foreclosure. 4

**BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF  
OHIO:**

WHEREAS, The national housing crisis that began in 2007 led 5  
to unprecedented home price declines and sustained and higher 6  
unemployment in certain parts of the country, including Ohio; 7  
and 8

WHEREAS, Families in these areas, including Ohio, struggled 9  
to make their monthly mortgage payments and to get out from 10  
under deeply underwater mortgages; and 11

WHEREAS, In 2008, Save the Dream Ohio was created as a 12  
multi-agency foreclosure prevention outreach initiative 13  
involving partners from state government, nonprofit housing 14  
counseling agencies, and legal aid organizations to address this 15  
crisis; and 16

WHEREAS, In 2010, the Ohio Housing Finance Agency received 17  
\$570.4 million from the United States Department of the 18

Treasury's Hardest Hit Fund to administer Ohio's foreclosure prevention program through Save the Dream Ohio; and 19

WHEREAS, Save the Dream Ohio has worked with 32 United States Department of Housing and Urban Development-approved nonprofit counseling agencies and over 350 mortgage servicers nationwide to provide assistance to over 24,000 homeowners at risk of foreclosure; and 21

WHEREAS, An additional \$60 million was designated for the Neighborhood Initiative Program to stabilize property values and prevent future foreclosures by removing and greening vacant and blighted properties; and 26

WHEREAS, Save the Dream Ohio had to stop accepting applications in August 2014, and payments on behalf of homeowners are expected to end in late 2016; United States Department of the Treasury guidelines specify that funds must be dispersed by December 31, 2017; and 30

WHEREAS, The Ohio Housing Finance Agency continues to administer the Save the Dream Ohio hotline to connect homeowners with HUD-approved housing counseling agencies and other resources; now therefore be it 35

RESOLVED, That we, the members of the House of Representatives of the 131st General Assembly of the State of Ohio request the Congress of the United States to renew funding for Save the Dream Ohio through the United States Department of the Treasury's Hardest Hit Fund, to continue to provide assistance to homeowners in the state of Ohio at risk of foreclosure; and be it further 39
