July 17, 1916, the act established the Farm Credit System as a	9

System is a network of independently-owned cooperatives that are	13
responsive to the needs of borrowers and adaptive to change, and	14

Federal Farm Loan Act of 1916. Currently, the Farm Credit System	18
provides more than \$7 billion in loans to more than 34,000	19
