Ronald Nabakowski and extend our heartfelt condolences to his 3

WHEREAS, Ronald Nabakowski left an indelible impression on 5  
the people whose lives he touched, and he will be remembered as a 6  
spirited individual who contributed immeasurably to the world 7  
around him. First elected to public service in 1971 as the Lorain 8  
City auditor, he served as a member of the Ohio State Senate, a 9  
commissioner for Lorain County, and the director of the Ohio 10  
Lottery before being named the clerk of courts for Lorain County, 11  
from which he retired in 2014, and the love, compassion, and 12  
understanding that he so readily extended to others will long 13

WHEREAS, Ronald Nabakowski's regard for improving the quality 15  
of life in our society was clearly evident in his personal 16  
sacrifices of time and effort to his family, friends, and 17  
community, and he will be remembered for his generosity, talents, 18

concern in all of his endeavors, and his absence will be keenly 20

Carolyn, Maya, Benjamin, and Isabelle, Ronald Nabakowski readily 26
