A BILL

To enact sections 5534.401, 5534.402, 5534.404, 1
5534.405, 5534.481, 5534.492, 5534.493, 2
5534.751, 5534.77, 5534.809, 5534.815, 5534.85, 3
5534.891, 5534.892, 5534.893, 5534.894, and 4
5534.895 of the Revised Code to designate 5
multiple memorial highways. 6

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 5534.401, 5534.402, 5534.404, 7
5534.405, 5534.481, 5534.492, 5534.493, 5534.751, 5534.77, 8
5534.809, 5534.815, 5534.85, 5534.891, 5534.892, 5534.893, 9
5534.894, and 5534.895 of the Revised Code be enacted to read as 10
follows: 11

Sec. 5534.401. That portion of the road known as state 12
route number sixty, running in a northerly and southerly 13
direction between the intersection of that route and county road 14
number ninety-seven and the intersection of that route and the 15
southern boundary of the municipal corporation of Zanesville in 16
Muskingum county, shall be known as "Lieutenant Michael J. Lutz 17
Memorial Highway." 18

The director of transportation may erect suitable markers 19
along the highway indicating its name. 20

Sec. 5534.402. That portion of the road known as state 21
route number one hundred forty-six, running in a northwesterly 22
and southeasterly direction between the intersection of that 23
route and Musselman drive and the intersection of state route 24
number one hundred forty-six and Shannon valley road, in 25
Muskingum county, shall be known as "Deputy Sheriff Robert M. 26
Tanner, Jr. Memorial Highway." 27

The director of transportation may erect suitable markers 28
along the highway indicating its name. 29

Sec. 5534.404. In addition to any other name prescribed in 30
the Revised Code or otherwise, the portion of the road known as 31
state route number four, running in a northerly and southerly 32
direction, between the intersection of that route and north Fair 33
avenue and the intersection of that route and state route number 34
one hundred twenty-nine, in Butler county only, shall be known 35
as the "Firefighter/Paramedic Patrick Wolterman Memorial 36
Highway." 37

The director of transportation may erect suitable markers 38
along the highway indicating its name. 39

Sec. 5534.405. In addition to any other name prescribed in 40

the Revised Code or otherwise, the eastbound and westbound lanes 41
of interstate route number two hundred seventy, commencing at 42
the interchange of that route and state route number three and 43
extending to the intersection of interstate route number two 44
hundred seventy and Cleveland avenue, in Franklin county, shall 45
be known as the "Officers Anthony Morelli and Eric Joering 46
Memorial Highway." 47

The director of transportation may erect suitable markers 48
along the highway indicating its name. 49

Sec. 5534.481. In addition to any other name prescribed in 50
the Revised Code or otherwise, the portion of the road known as 51
state route number three hundred seventeen, running in a 52
northerly and southerly direction, between the intersection of 53
that route and Gerling boulevard and the intersection of that 54
route and Wingate road, in Madison township in Franklin county 55
only, shall be known as the "Patrolman Dane L. Rowe Memorial 56
Highway." 57

The director of transportation may erect suitable markers 58
along the highway indicating its name. 59

Sec. 5534.492. In addition to any other name prescribed in 60
the Revised Code or otherwise, the northbound and southbound 61
lanes of interstate route number seventy-one between the Dana 62
avenue exit and the Montgomery road exit, in Hamilton county, 63
shall be known as the "Officer Sonny L. Kim Memorial Highway." 64

The director of transportation may erect suitable markers 65
along the highway indicating its name. 66

Sec. 5534.493. In addition to any other name prescribed in 67
the Revised Code or otherwise, the eastbound and westbound lanes 68
of United States route number forty within the village of 69

Kirkersville only, in Licking county, shall be known as the 70
"Kirkersville Chief Steven "Eric" DiSario Memorial Highway." 71

The director of transportation may erect suitable markers 72
along the highway indicating its name. 73

Sec. 5534.751. In addition to any other name prescribed in 74
the Revised Code or otherwise, the portion of the road known as 75
state route number ninety-three running in a northeasterly and 76
southwesterly direction between the intersections of that route 77
and state route number five hundred sixteen and that route and 78
sunset boulevard road northwest in Tuscarawas county shall be 79
known as the "PFC Oscar F. Nicewander Memorial Highway." 80

The director of transportation may erect suitable markers 81
along the highway indicating its name. 82

Sec. 5534.77. In addition to any other name prescribed in 83
the Revised Code or otherwise, the northbound and southbound 84
lanes of state route number sixty-five between the intersections 85
of Elm street and Rosedale place, in the municipal corporation 86
of Rossford in Wood county, shall be known as the "Marine Sgt. 87
David R. Christoff Memorial Highway." 88

The director of transportation may erect suitable markers 89
along the highway indicating its name. 90

Sec. 5534.809. In addition to any other name prescribed in 91
the Revised Code or otherwise, the portion of the road known as 92
state route number five hundred twenty running in an easterly 93
and westerly direction between the intersections of that route 94
and state route number five hundred fourteen and that route and 95
United States route number sixty-two in Holmes county shall be 96
known as the "Cpl. Jerry Robert Spitler Memorial Highway." 97

The director of transportation may erect suitable markers 98

along the highway indicating its name. 99

Sec. 5534.815. In addition to any other name prescribed by 100
the Revised Code or otherwise, that portion of the road known as 101
state route number four, running in a southwesterly and 102
northeasterly direction, between the intersection of that route 103
and Barks road west and that route and Gooding road, in Marion 104
county only, shall be known as the "Army Cpt. Stephen J. Chaney 105
Memorial Highway." 106

The director of transportation may erect suitable markers 107
along the highway indicating its name. 108

Sec. 5534.85. In addition to any other name prescribed in 109
the Revised Code or otherwise, the portion of state route number 110
fifty-five, running in an easterly and westerly direction, 111
commencing at the intersection of that route and state route 112
number five hundred seventy-one and extending to the 113
intersection of that route and state route number forty-eight, 114
in Miami county only, shall be known as the "PFC Marc L. Cole 115
Memorial Highway." 116

The director of transportation may erect suitable markers 117
along the highway indicating its name. 118

Sec. 5534.891. In addition to any other name prescribed in 119
the Revised Code or otherwise, the northbound and southbound 120
lanes of state route number one hundred sixty-four, within the 121
municipal corporation of Bergholz only, shall be known as the 122
"Pvt. David Rhoades Memorial Highway." 123

The director of transportation may erect suitable markers 124
along the highway indicating its name. 125

Sec. 5534.892. In addition to any other name prescribed in 126
the Revised Code or otherwise, the portion of the road known as 127

United States route number thirty, running in an easterly and 128
westerly direction, between the intersection of that route and 129
state route two hundred thirty-one and the intersection of that 130
route and state route five hundred ninety-eight, in Wyandot and 131
Crawford counties, shall be known as the "First Lt. Harry L. 132
Martin Memorial Highway." 133

The director of transportation may erect suitable markers 134
along the highway indicating its name. 135

Sec. 5534.893. In addition to any other name in the 136
Revised Code or otherwise, the northbound and southbound lanes 137
of United States route number thirty-three between McCalla road 138
and township road number ninety-nine, in Logan county only, 139
shall be known as the "Army Staff Sgt. Dennis J. Hansen Memorial 140
Highway." 141

The director of transportation may erect suitable markers 142
along the highway indicating its name. 143

Sec. 5534.894. In addition to any other name in the 144
Revised Code or otherwise, the northbound and southbound lanes 145
of United States route number thirty-three between township road 146
number ninety-nine and county road number one hundred thirty, in 147
Logan county only, shall be known as the "Army National Guard 148
Sgt. Jeremy M. Hodge Memorial Highway." 149

The director of transportation may erect suitable markers 150
along the highway indicating its name. 151

Sec. 5534.895. In addition to any other name in the 152
Revised Code or otherwise, the northbound and southbound lanes 153
of United States route number thirty-three between east Sandusky 154
avenue and county road number five, in Logan county only, shall 155
be known as the "Marine Gunnery Sgt. David S. Spicer Memorial 156
