BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4123.026 of the Revised Code be	9
amended to read as follows:	10
Sec. 4123.026. (A) The administrator of workers'	11
compensation, or a self-insuring public employer for the peace	12
officers, firefighters, and emergency medical workers employed	13
by or volunteering for that self-insuring public employer, and	14
personnel employed by a detention facility that is a self-	15
insuring employer, including a corrections officer, shall pay	16
the costs of conducting post-exposure medical diagnostic	17
services, consistent with the standards of medical care existing	18
