### BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4511.132 of the Revised Code be	6

Sec. 4511.132. (A) The driver of a vehicle, streetcar, or	8
trackless trolley who approaches an intersection where traffic	9
is controlled by traffic control signals shall do all of the	10
following, if the signal facing the driver exhibits no colored	11
lights or colored lighted arrows, exhibits a combination of such	12
lights or arrows that fails to clearly indicate the assignment	13
of right-of-way, or, if the vehicle is a bicycle, the signals	14
are otherwise malfunctioning, including due to the failure of a	15
vehicle detector to detect the <u>vehicle</u> <u>presence of the bicycle</u> :	16
(1) Stop at a clearly marked stop line, but if none, stop	17
(1) Stop at a crearry marked Stop Time, but it nome, Stop	Ι/

intersection, or, if none, stop before entering the	19

(2) Yield the right-of-way to all vehicles, streetcars, or	21	
trackless trolleys in the intersection or approaching on an		
intersecting road, if the vehicles, streetcars, or trackless		
trolleys will constitute an immediate hazard during the time the	24	
driver is moving across or within the intersection or junction		
of roadways;		
(3) Exercise ordinary care while proceeding through the	27	
intersection.		
(B) Except as otherwise provided in this division, whoever	29	
violates this section is guilty of a minor misdemeanor. If,	30	
within one year of the offense, the offender previously has been		
convicted of or pleaded guilty to one predicate motor vehicle or	32	
traffic offense, whoever violates this section is guilty of a	33	
misdemeanor of the fourth degree. If, within one year of the		
offense, the offender previously has been convicted of two or	35	
more predicate motor vehicle or traffic offenses, whoever	36	
violates this section is guilty of a misdemeanor of the third	37	
degree.
