**A CONCURRENT RESOLUTION**

To condemn the Boycott, Divestment, and Sanctions 1  
movement and increasing incidents of anti-Semitism. 2

**BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF  
OHIO (THE SENATE CONCURRING):**

WHEREAS, The citizens of the State of Ohio have a history 3  
of standing against bigotry, oppression, discrimination, and 4  
injustice; and 5

WHEREAS, Ohio and Israel have a long history of friendship 6  
and are great allies in support of each other's interests; and 7

WHEREAS, The State of Israel, the only democracy in the 8  
Middle East, is the greatest friend and ally of the United 9  
States in the Middle East; and 10

WHEREAS, Ohio is committed to increasing the ties and 11  
interactions in business, government, the arts, culture, and 12  
education between the State of Ohio and the State of Israel, 13  
further strengthening the historic ties between our State and 14  
that country; and 15

WHEREAS, Ties between Ohio's and Israel's academic, 16  
research, business, and nonprofit communities are both robust 17  
and longstanding; and 18

WHEREAS, The elected representatives of Ohio recognize the 19  
importance of expressing their unabridged support for the Jewish 20  
people and the State of Israel's right to exist and thrive, and 21  
their unabridged support for Israel's right of self-defense; and 22

WHEREAS, There are increasing incidents of anti-Semitism 23  
around the world, including across the United States and in 24  
Ohio, including desecration of Jewish religious sites; and 25

WHEREAS, The international Boycott, Divestment, and 26  
Sanctions movement is one of the main vehicles for legitimizing 27  
anti-Semitism on campus and advocating the elimination of the 28  
Jewish State; and 29

WHEREAS, Anti-Israel activities and activities promoting 30  
the Boycott, Divestment, and Sanctions movement against Israel 31  
are widespread in the State of Ohio, including on several 32  
university campuses and in other Ohio communities, and 33  
contribute to anti-Semitic and anti-Zionistic propaganda and 34  
threats to both American and Israeli Jewish students, and result 35  
in deliberate interference with the learning environment of all 36  
students; and 37

WHEREAS, The dramatic increase in Boycott, Divestment, and 38  
Sanctions campaign activities on college campuses around the 39  
country has resulted in increased animosity and intimidation 40  
against Jewish students, negatively impacting student 41  
programming of vital importance to all American students related 42  
to the State of Israel and politics in the Middle East; and 43

WHEREAS, Leaders of the Boycott, Divestment, and Sanctions 44  
movement say their goal is to eliminate Israel as the home of 45  
the Jewish people, and signs and messaging at anti-Israel 46

rallies have adopted the Boycott, Divestment, and Sanctions 47  
movement's theme slogan, "Palestine forever, Israel Never Ever" 48  
meaning that the State of Israel would cease to exist, falsely 49  
denying the Jewish people's and Israel's historical connection 50  
to its ancient home in the Land of Israel, including the present 51  
day State of Israel, and Jerusalem, Judea, and Samaria, which 52  
were the heartland of the ancient nations of Israel and Judah; 53  
and 54

WHEREAS, Ohio's elected representatives who defend the 55  
inalienable right to free speech understand that the goals and 56  
activities of Boycott, Divestment, and Sanctions campaigns in 57  
Ohio are harmful to the State's relationships with Ohio's Jewish 58  
citizens, with Ohio's non-Jewish citizens who support the State 59  
of Israel and the Jewish people, and with the Jewish homeland, 60  
Israel, and have a deleterious impact on the educational 61  
environment; and 62

WHEREAS, The Boycott, Divestment, and Sanctions campaign's 63  
call for academic boycotts has been condemned by many of our 64  
nation's largest academic associations, over two hundred fifty 65  
university presidents, and many other leading scholars as a 66  
violation of the bedrock principle of academic freedom; now 67  
therefore be it 68

RESOLVED, That the members of the General Assembly condemn 69  
the international Boycott, Divestment, and Sanctions movement 70  
and its activities in Ohio for legitimizing anti-Semitism and 71  
for seeking to undermine the Jewish people's right to self- 72  
determination, which they are fulfilling in the State of Israel; 73  
and be it further 74

RESOLVED, That the members of the General Assembly condemn 75  
activities that contribute directly or indirectly to the denial, 76  
violation, or delegitimization of any people's academic freedom, 77  
including, but not limited to, promotion of academic boycotts by 78

the Boycott, Divestment, and Sanctions movement against Israel; 79  
and be it further 80

RESOLVED, That the members of the General Assembly consider 81  
the international Boycott, Divestment, and Sanctions movement 82  
and its agenda inherently antithetical and deeply damaging to 83  
the causes of peace, justice, equality, democracy, and human 84  
rights for all peoples in the Middle East and in the United 85  
States; and be it further 86

RESOLVED, That we, the members of the 132nd General 87  
Assembly of the State of Ohio, reaffirm our support for the 88  
State of Israel, recognize that the Jewish people are indigenous 89  
to the land of Israel, condemn all attacks on the people of 90  
Israel, support Israel's right to engage in lawful acts of self- 91  
defense, and oppose all attempts to deny the legitimacy of 92  
Israel as a sovereign state; and be it further 93

RESOLVED, That we, the members of the 132nd General 94  
Assembly of the State of Ohio, reaffirm our position that the 95  
trustees, administrators, and educators at all levels in our 96  
universities in Ohio, must take an active stand against all 97  
anti-Semitic actions and intimidation taken against Jewish 98  
students on their campuses, whereby all students may feel safe, 99  
and be safe, from harm due to these pernicious activities; and 100  
be it further 101

RESOLVED, That the members of the General Assembly 102  
encourage and support the exercise of free speech and civil 103  
debate, particularly on college campuses, and further encourage 104  
university and college administrations to curb any impediments 105  
to free speech and any abridgment of free speech on campus by 106  
any individuals or groups, and urge them to take disciplinary 107  
action against all students, faculty, and administrators who 108  
engage in actions that abridge free speech on campus in 109  
violation of the First Amendment to the Constitution of the 110

United States; and be it further 111

RESOLVED, That the Clerk of the House of Representatives 112  
transmit duly authenticated copies of this resolution to the 113  
President of the United States, the Speaker and Clerk of the 114  
United States House of Representatives, the President and 115  
Secretary of the United States Senate, the Chancellor of Higher 116  
Education and each of the nine members of the Ohio Board of 117  
Regents, the provosts and chairpersons of the boards of trustees 118  
of all Ohio public and private colleges and universities, and 119  
the Israeli Embassy in Washington, D.C., for transmission to the 120  
proper authorities in the State of Israel. 121
