## A JOINT RESOLUTION

Proposing to enact Section 12 of Article XV of the	1
Constitution of the State of Ohio to subject any	2
public employee collective bargaining representative	3
to an annual election to remain certified as the	4
exclusive representative.	5

Be it resolved by the General Assembly of the State of	6
Ohio, three-fifths of the members elected to each house	7
concurring herein, that there shall be submitted to the electors	8
of the state, in the manner prescribed by law at the general	9
election to be held on November 3, 2020, a proposal to enact	10
Section 12 of Article XV of the Constitution of the State of	11
Ohio to read as follows:	12

ARTICLE XV	13
Section 12. (A) As used in this section:	14
(1) "Exclusive representative" means any employee	15
organization certified or recognized as an exclusive	16
representative of all the public employees in a bargaining unit.	17
(2) "Employee organization" means any labor or bona fide	18

organization in which public employees participate and that	19	
exists for the purpose, in whole or in part, of dealing with	20	
public employers concerning grievances, labor disputes, wages,	21	
hours, terms, and other conditions of employment.	22	
(3) "Public employee" means any person holding a position	23	
by appointment or employment in the service of a public	24	
employer.		
(4) "Public employer" means the state or any political	26	
subdivision of the state located entirely within the state.	27	
(B) An exclusive representative who enters into a	28	
collective bargaining agreement with a public employer on or	29	
after the effective date of this section annually shall be the	30	
subject of an election to certify that the exclusive	31	
representative retains the support of a majority of all of the	32	
employees in a bargaining unit.	33	
(1) An exclusive representative that receives the support	34	
of a majority of all of the employees in the bargaining unit	35	
remains certified as the exclusive representative.	36	
(2) An exclusive representative that does not receive the	37	
support of a majority of all of the employees in the bargaining	38	
unit is no longer the exclusive representative of the employees	39	
in the bargaining unit.	40	
(C) Any collective bargaining agreement entered into	41	
between an exclusive representative and a public employer on or	42	
after the effective date of this section shall specify that, if	43	
the exclusive representative is decertified under division (B)	44	
(2) of this section, the agreement expires on the date the	45	
exclusive representative is decertified.	46
