**A BILL**

To amend section 4501.21 and to enact sections 1  
4503.961, 4503.962, and 4503.963 of the Revised 2  
Code to create the "Fairfield Senior High 3  
School," "Ross High School," and "Hamilton High 4  
School" license plates. 5

**BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:**

**Section 1.** That section 4501.21 be amended and sections 6  
4503.961, 4503.962, and 4503.963 of the Revised Code be enacted 7  
to read as follows: 8

**Sec. 4501.21.** (A) There is hereby created in the state 9  
treasury the license plate contribution fund. The fund shall 10  
consist of all contributions paid by motor vehicle registrants 11  
and collected by the registrar of motor vehicles pursuant to 12  
sections 4503.491, 4503.492, 4503.493, 4503.494, 4503.495, 13  
4503.496, 4503.497, 4503.498, 4503.499, 4503.4910, 4503.4911, 14  
4503.50, 4503.501, 4503.502, 4503.505, 4503.51, 4503.514, 15  
4503.521, 4503.522, 4503.523, 4503.524, 4503.525, 4503.526, 16  
4503.528, 4503.529, 4503.531, 4503.534, 4503.545, 4503.55, 17  
4503.551, 4503.552, 4503.553, 4503.554, 4503.555, 4503.556, 18

4503.561, 4503.562, 4503.564, 4503.565, 4503.566, 4503.567, 19  
4503.576, 4503.577, 4503.591, 4503.592, 4503.594, 4503.595, 20

(B) The registrar shall pay the contributions the 32  
registrar collects in the fund as follows: 33

The registrar shall pay the contributions received 34  
pursuant to section 4503.491 of the Revised Code to the breast 35  
cancer fund of Ohio, which shall use that money only to pay for 36  
programs that provide assistance and education to Ohio breast 37  
cancer patients and that improve access for such patients to 38  
quality health care and clinical trials and shall not use any of 39  
the money for abortion information, counseling, services, or 40  
other abortion-related activities. 41

The registrar shall pay the contributions the registrar 42  
receives pursuant to section 4503.492 of the Revised Code to the 43  
organization cancer support community central Ohio, which shall 44  
deposit the money into the Sheryl L. Kraner Fund of that 45  
organization. Cancer support community central Ohio shall expend 46  
the money it receives pursuant to this division only in the same 47  
manner and for the same purposes as that organization expends 48

other money in that fund. 49

The registrar shall pay the contributions received 50  
pursuant to section 4503.493 of the Revised Code to the autism 51  
society of Ohio, which shall use the contributions for programs 52  
and autism awareness efforts throughout the state. 53

The registrar shall pay the contributions the registrar 54  
receives pursuant to section 4503.494 of the Revised Code to the 55  
national multiple sclerosis society for distribution in equal 56  
amounts to the northwestern Ohio, Ohio buckeye, and Ohio valley 57  
chapters of the national multiple sclerosis society. These 58  
chapters shall use the money they receive under this section to 59  
assist in paying the expenses they incur in providing services 60  
directly to their clients. 61

The registrar shall pay the contributions the registrar 62  
receives pursuant to section 4503.495 of the Revised Code to the 63  
national pancreatic cancer foundation, which shall use the money 64  
it receives under this section to assist those who suffer with 65  
pancreatic cancer and their families. 66

The registrar shall pay the contributions the registrar 67  
receives pursuant to section 4503.496 of the Revised Code to the 68  
Ohio sickle cell and health association, which shall use the 69  
contributions to help support educational, clinical, and social 70  
support services for adults who have sickle cell disease. 71

The registrar shall pay the contributions the registrar 72  
receives pursuant to section 4503.497 of the Revised Code to the 73  
St. Baldrick's foundation, which shall use the contributions for 74  
its research and other programs. 75

The registrar shall pay the contributions the registrar 76  
receives pursuant to section 4503.498 of the Revised Code to 77

special olympics Ohio, inc., which shall use the contributions 78  
for its programs, charitable efforts, and other activities. 79

The registrar shall pay the contributions the registrar 80  
receives pursuant to section 4503.499 of the Revised Code to the 81  
children's glioma cancer foundation, which shall use the 82  
contributions for its research and other programs. 83

The registrar shall pay the contributions the registrar 84  
receives pursuant to section 4503.4910 of the Revised Code to 85  
the KylerStrong foundation, which shall use the contributions to 86  
raise awareness of brain cancer caused by diffuse intrinsic 87  
pontine glioma and to fund research for the cure of such cancer. 88

The registrar shall pay the contributions the registrar 89  
receives pursuant to section 4503.4911 of the Revised Code to 90  
the research institution for childhood cancer at nationwide 91  
children's hospital, which shall use the contributions to fund 92  
research for the cure of childhood cancers. 93

The registrar shall pay the contributions the registrar 94  
receives pursuant to section 4503.50 of the Revised Code to the 95  
future farmers of America foundation, which shall deposit the 96  
contributions into its general account to be used for 97  
educational and scholarship purposes of the future farmers of 98  
America foundation. 99

The registrar shall pay the contributions the registrar 100  
receives pursuant to section 4503.501 of the Revised Code to the 101  
4-H youth development program of the Ohio state university 102  
extension program, which shall use those contributions to pay 103  
the expenses it incurs in conducting its educational activities. 104

The registrar shall pay the contributions received 105  
pursuant to section 4503.502 of the Revised Code to the Ohio 106

cattlemen's foundation, which shall use those contributions for 107  
scholarships and other educational activities. 108

The registrar shall pay the contributions received 109  
pursuant to section 4503.505 of the Revised Code to the 110  
organization Ohio region phi theta kappa, which shall use those 111  
contributions for scholarships for students who are members of 112  
that organization. 113

The registrar shall pay each contribution the registrar 114  
receives pursuant to section 4503.51 of the Revised Code to the 115  
university or college whose name or marking or design appears on 116  
collegiate license plates that are issued to a person under that 117  
section. A university or college that receives contributions 118  
from the fund shall deposit the contributions into its general 119  
scholarship fund. 120

The registrar shall pay the contributions the registrar 121  
receives pursuant to section 4503.514 of the Revised Code to the 122  
university of Notre Dame in South Bend, Indiana, for purposes of 123  
awarding grants or scholarships to residents of Ohio who attend 124  
the university. The university shall not use any of the funds it 125  
receives for purposes of administering the scholarship program. 126  
The registrar shall enter into appropriate agreements with the 127  
university of Notre Dame to effectuate the distribution of such 128  
funds as provided in this section. 129

The registrar shall pay the contributions the registrar 130  
receives pursuant to section 4503.521 of the Revised Code to the 131  
Ohio bicycle federation to assist that organization in paying 132  
for the educational programs it sponsors in support of Ohio 133  
cyclists of all ages. 134

The registrar shall pay the contributions the registrar 135

receives pursuant to section 4503.522 of the Revised Code to the 136  
"friends of Perry's victory and international peace memorial, 137  
incorporated," a nonprofit corporation organized under the laws 138  
of this state, to assist that organization in paying the 139  
expenses it incurs in sponsoring or holding charitable, 140  
educational, and cultural events at the monument. 141

The registrar shall pay the contributions the registrar 142  
receives pursuant to section 4503.523 of the Revised Code to the 143  
fairport lights foundation, which shall use the money to pay for 144  
the restoration, maintenance, and preservation of the 145  
lighthouses of fairport harbor. 146

The registrar shall pay the contributions the registrar 147  
receives pursuant to section 4503.524 of the Revised Code to the 148  
Massillon tiger football booster club, which shall use the 149  
contributions only to promote and support the football team of 150  
Washington high school of the Massillon city school district. 151

The registrar shall pay the contributions the registrar 152  
receives pursuant to section 4503.525 of the Revised Code to the 153  
United States power squadron districts seven, eleven, twenty- 154  
four, and twenty-nine in equal amounts. Each power squadron 155  
district shall use the money it receives under this section to 156  
pay for the educational boating programs each district holds or 157  
sponsors within this state. 158

The registrar shall pay the contributions the registrar 159  
receives pursuant to section 4503.526 of the Revised Code to the 160  
Ohio district Kiwanis foundation of the Ohio district of Kiwanis 161  
international, which shall use the money it receives under this 162  
section to pay the costs of its educational and humanitarian 163  
activities. 164

The registrar shall pay the contributions the registrar receives pursuant to section 4503.528 of the Revised Code to the Ohio children's alliance, which shall use the money it receives under this section to pay the expenses it incurs in advancing its mission of sustainably improving the provision of services to children, young adults, and families in this state.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.529 of the Revised Code to the Ohio nurses foundation. The foundation shall use the money it receives under this section to provide educational scholarships to assist individuals who aspire to join the nursing profession, to assist nurses in the nursing profession who seek to advance their education, and to support persons conducting nursing research concerning the evidence-based practice of nursing and the improvement of patient outcomes.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.531 of the Revised Code to the thank you foundation, incorporated, a nonprofit corporation organized under the laws of this state, to assist that organization in paying for the charitable activities and programs it sponsors in support of United States military personnel, veterans, and their families.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.534 of the Revised Code to the disabled American veterans department of Ohio, to be used for programs that serve disabled American veterans and their families.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.55 of the Revised Code to the pro football hall of fame, which shall deposit the contributions

into a special bank account that it establishes and which shall 195  
be separate and distinct from any other account the pro football 196  
hall of fame maintains, to be used exclusively for the purpose 197  
of promoting the pro football hall of fame as a travel 198  
destination. 199

The registrar shall pay the contributions that are paid to 200  
the registrar pursuant to section 4503.545 of the Revised Code 201  
to the national rifle association foundation, which shall use 202  
the money to pay the costs of the educational activities and 203  
programs the foundation holds or sponsors in this state. 204

The registrar shall pay to the Ohio pet fund the 205  
contributions the registrar receives pursuant to section 206  
4503.551 of the Revised Code and any other money from any other 207  
source, including donations, gifts, and grants, that is 208  
designated by the source to be paid to the Ohio pet fund. The 209  
Ohio pet fund shall use the moneys it receives under this 210  
section to support programs for the sterilization of dogs and 211  
cats and for educational programs concerning the proper 212  
veterinary care of those animals, and for expenses of the Ohio 213  
pet fund that are reasonably necessary for it to obtain and 214  
maintain its tax-exempt status and to perform its duties. 215

The registrar shall pay the contributions the registrar 216  
receives pursuant to section 4503.552 of the Revised Code to the 217  
rock and roll hall of fame and museum, incorporated. 218

The registrar shall pay the contributions the registrar 219  
receives pursuant to section 4503.553 of the Revised Code to the 220  
Ohio coalition for animals, incorporated, a nonprofit 221  
corporation. Except as provided in division (B) of this section, 222  
the coalition shall distribute the money to its members, and the 223  
members shall use the money only to pay for educational, 224



charitable, and other programs of each coalition member that 225  
provide care for unwanted, abused, and neglected horses. The 226  
Ohio coalition for animals may use a portion of the money to pay 227  
for reasonable marketing costs incurred in the design and 228  
promotion of the license plate and for administrative costs 229  
incurred in the disbursement and management of funds received 230  
under this section. 231

The registrar shall pay the contributions the registrar 232  
receives pursuant to section 4503.554 of the Revised Code to the 233  
Ohio state council of the knights of Columbus, which shall use 234  
the contributions to pay for its charitable activities and 235  
programs. 236

The registrar shall pay the contributions the registrar 237  
receives pursuant to section 4503.555 of the Revised Code to the 238  
western reserve historical society, which shall use the 239  
contributions to fund the Crawford auto aviation museum. 240

The registrar shall pay the contributions the registrar 241  
receives pursuant to section 4503.556 of the Revised Code to the 242  
Erica J. Holloman foundation, inc., for the awareness of triple 243  
negative breast cancer. The foundation shall use the 244  
contributions for charitable and educational purposes. 245

The registrar shall pay the contributions the registrar 246  
receives pursuant to section 4503.561 of the Revised Code to the 247  
state of Ohio chapter of ducks unlimited, inc., which shall 248  
deposit the contributions into a special bank account that it 249  
establishes. The special bank account shall be separate and 250  
distinct from any other account the state of Ohio chapter of 251  
ducks unlimited, inc., maintains and shall be used exclusively 252  
for the purpose of protecting, enhancing, restoring, and 253  
managing wetlands and conserving wildlife habitat. The state of 254

Ohio chapter of ducks unlimited, inc., annually shall notify the registrar in writing of the name, address, and account to which such payments are to be made.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.562 of the Revised Code to the Mahoning river consortium, which shall use the money to pay the expenses it incurs in restoring and maintaining the Mahoning river watershed.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.564 of the Revised Code to Antioch college for the use of the Glen Helen ecology institute to pay expenses related to the Glen Helen nature preserve.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.565 of the Revised Code to the conservancy for Cuyahoga valley national park, which shall use the money in support of the park.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.566 of the Revised Code to the Ottawa national wildlife refuge, which shall use the contributions for wildlife preservation purposes.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.567 of the Revised Code to the girls on the run of Franklin county, inc., which shall use the contributions to support the activities of the organization.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.576 of the Revised Code to the Ohio state beekeepers association, which shall use those contributions to promote beekeeping, provide educational information about beekeeping, and to support other state and

local beekeeping programs.	284
The registrar shall pay the contributions the registrar receives pursuant to section 4503.577 of the Revised Code to the national aviation hall of fame, which shall use the contributions to fulfill its mission of honoring aerospace legends to inspire future leaders.	285 286 287 288 289

The registrar shall pay the contributions the registrar 314  
receives pursuant to section 4503.595 of the Revised Code to the 315  
Stan Hywet hall and gardens. 316

The registrar shall pay the contributions the registrar 317  
receives pursuant to section 4503.67 of the Revised Code to the 318  
Dan Beard council of the boy scouts of America. The council 319  
shall distribute all contributions in an equitable manner 320  
throughout the state to regional councils of the boy scouts. 321

The registrar shall pay the contributions the registrar 322  
receives pursuant to section 4503.68 of the Revised Code to the 323  
great river council of the girl scouts of the United States of 324  
America. The council shall distribute all contributions in an 325  
equitable manner throughout the state to regional councils of 326  
the girl scouts. 327

The registrar shall pay the contributions the registrar 328  
receives pursuant to section 4503.69 of the Revised Code to the 329  
Dan Beard council of the boy scouts of America. The council 330  
shall distribute all contributions in an equitable manner 331  
throughout the state to regional councils of the boy scouts. 332

The registrar shall pay the contributions the registrar 333  
receives pursuant to section 4503.701 of the Revised Code to the 334  
Prince Hall grand lodge of free and accepted masons of Ohio, 335  
which shall use the contributions for scholarship purposes. 336

The registrar shall pay the contributions the registrar 337  
receives pursuant to section 4503.702 of the Revised Code to the 338  
Ohio Association of the Improved Benevolent and Protective Order 339  
of the Elks of the World, which shall use the funds for 340  
charitable purposes. 341

The registrar shall pay the contributions the registrar 342  
receives pursuant to section 4503.71 of the Revised Code to the 343  
fraternal order of police of Ohio, incorporated, which shall 344  
deposit the fees into its general account to be used for 345  
purposes of the fraternal order of police of Ohio, incorporated. 346

The registrar shall pay the contributions the registrar 347  
receives pursuant to section 4503.711 of the Revised Code to the 348  
fraternal order of police of Ohio, incorporated, which shall 349  
deposit the contributions into an account that it creates to be 350  
used for the purpose of advancing and protecting the law 351  
enforcement profession, promoting improved law enforcement 352  
methods, and teaching respect for law and order. 353

The registrar shall pay the contributions received 354  
pursuant to section 4503.712 of the Revised Code to Ohio 355  
concerns of police survivors, which shall use those 356  
contributions to provide whatever assistance may be appropriate 357  
to the families of Ohio law enforcement officers who are killed 358  
in the line of duty. 359

The registrar shall pay the contributions received 360  
pursuant to section 4503.713 of the Revised Code to the greater 361  
Cleveland peace officers memorial society, which shall use those 362  
contributions to honor law enforcement officers who have died in 363  
the line of duty and support its charitable purposes. 364

The registrar shall pay the contributions the registrar 365  
receives pursuant to section 4503.715 of the Revised Code to the 366  
fallen linemen organization, which shall use the contributions 367  
to recognize and memorialize fallen linemen and support their 368  
families. 369

The registrar shall pay the contributions the registrar 370

receives pursuant to section 4503.72 of the Revised Code to the 371  
organization known on March 31, 2003, as the Ohio CASA/GAL 372  
association, a private, nonprofit corporation organized under 373  
Chapter 1702. of the Revised Code. The Ohio CASA/GAL association 374  
shall use these contributions to pay the expenses it incurs in 375  
administering a program to secure the proper representation in 376  
the courts of this state of abused, neglected, and dependent 377  
children, and for the training and supervision of persons 378  
participating in that program. 379

The registrar shall pay the contributions the registrar 380  
receives pursuant to section 4503.722 of the Revised Code to the 381  
Down Syndrome Association of Central Ohio, which shall use the 382  
contributions for advocacy purposes throughout the state. 383

The registrar shall pay the contributions the registrar 384  
receives pursuant to section 4503.73 of the Revised Code to 385  
Wright B. Flyer, incorporated, which shall deposit the 386  
contributions into its general account to be used for purposes 387  
of Wright B. Flyer, incorporated. 388

The registrar shall pay the contributions the registrar 389  
receives pursuant to section 4503.732 of the Revised Code to the 390  
Siegel Shuster society, a nonprofit organization dedicated to 391  
commemorating and celebrating the creation of Superman in 392  
Cleveland, Ohio. 393

The registrar shall pay the contributions the registrar 394  
receives pursuant to section 4503.733 of the Revised Code to the 395  
central Ohio chapter of the juvenile diabetes research 396  
foundation, which shall distribute the contributions to the 397  
chapters of the juvenile diabetes research foundation in whose 398  
geographic territory the person who paid the contribution 399  
resides. 400

The registrar shall pay the contributions the registrar 401  
receives pursuant to section 4503.734 of the Revised Code to the 402  
Ohio highway patrol auxiliary foundation, which shall use the 403  
contributions to fulfill the foundation's mission of supporting 404  
law enforcement education and assistance. 405

The registrar shall pay the contributions the registrar 406  
receives pursuant to section 4503.74 of the Revised Code to the 407  
Columbus zoological park association, which shall disburse the 408  
moneys to Ohio's major metropolitan zoos, as defined in section 409  
4503.74 of the Revised Code, in accordance with a written 410  
agreement entered into by the major metropolitan zoos. 411

The registrar shall pay the contributions the registrar 412  
receives pursuant to section 4503.75 of the Revised Code to the 413  
rotary foundation, located on March 31, 2003, in Evanston, 414  
Illinois, to be placed in a fund known as the permanent fund and 415  
used to endow educational and humanitarian programs of the 416  
rotary foundation. 417

The registrar shall pay the contributions the registrar 418  
receives pursuant to section 4503.751 of the Revised Code to the 419  
Ohio association of realtors, which shall deposit the 420  
contributions into a property disaster relief fund maintained 421  
under the Ohio realtors charitable and education foundation. 422

The registrar shall pay the contributions the registrar 423  
receives pursuant to section 4503.752 of the Revised Code to 424  
buckeye corvettes, incorporated, which shall use the 425  
contributions to pay for its charitable activities and programs. 426

The registrar shall pay the contributions the registrar 427  
receives pursuant to section 4503.763 of the Revised Code to the 428  
Ohio history connection to be used solely to build, support, and 429

maintain the Ohio battleflag collection within the Ohio history 430  
connection. 431

The registrar shall pay the contributions the registrar 432  
receives pursuant to section 4503.764 of the Revised Code to the 433  
Medina county historical society, which shall use those 434  
contributions to distribute between the various historical 435  
societies and museums in Medina county. 436

The registrar shall pay the contributions the registrar 437  
receives pursuant to section 4503.765 of the Revised Code to the 438  
Amaranth grand chapter foundation, which shall use the 439  
contributions for communal outreach, charitable service, and 440  
scholarship purposes. 441

The registrar shall pay the contributions the registrar 442  
receives pursuant to section 4503.85 of the Revised Code to the 443  
Ohio sea grant college program to be used for Lake Erie area 444  
research projects. 445

The registrar shall pay the contributions the registrar 446  
receives pursuant to section 4503.86 of the Revised Code to the 447  
Ohio Lincoln highway historic byway, which shall use those 448  
contributions solely to promote and support the historical 449  
preservation and advertisement of the Lincoln highway in this 450  
state. 451

The registrar shall pay the contributions the registrar 452  
receives pursuant to section 4503.87 of the Revised Code to the 453  
Grove City little league dream field fund, which shall use those 454  
contributions solely to build, maintain, and improve youth 455  
baseball fields within the municipal corporation of Grove City. 456

The registrar shall pay the contributions the registrar 457  
receives pursuant to section 4503.871 of the Revised Code to the 458



Solon city school district. The school district shall use the 459  
contributions it receives to pay the expenses it incurs in 460  
providing services to the school district's students that assist 461  
in developing or maintaining the mental and emotional well-being 462  
of the students. The services provided may include bereavement 463  
counseling, instruction in defensive driving techniques, 464  
sensitivity training, and the counseling and education of 465  
students regarding bullying, dating violence, drug abuse, 466  
suicide prevention, and human trafficking. The school district 467  
superintendent or, in the school district superintendent's 468  
discretion, the appropriate school principal or appropriate 469  
school counselors shall determine any charitable organizations 470  
that the school district hires to provide those services. The 471  
school district also may use the contributions it receives to 472  
pay for members of the faculty of the school district to receive 473  
training in providing such services to the students of the 474  
school district. The school district shall ensure that any 475  
charitable organization that is hired by the district is exempt 476  
from federal income taxation under subsection 501(c)(3) of the 477  
Internal Revenue Code. The school district shall not use the 478  
contributions it receives for any other purpose. 479

The registrar shall pay the contributions the registrar 480

reserved license plate under section 4503.40 or 4503.42 of the 995  
Revised Code. Upon receipt of the completed application and 996  
compliance by the applicant with divisions (B) and (C) of this 997  
section, the registrar shall issue to the applicant the 998  
appropriate vehicle registration and a set of "Hamilton High 999  
School" license plates and a validation sticker, or a validation 1000  
sticker alone when required by section 4503.191 of the Revised 1001  
Code. 1002

In addition to the letters and numbers ordinarily 1003  
inscribed on the license plates, "Hamilton High School" license 1004  
plates shall display an appropriate logo and words that are 1005  
selected by representatives of Hamilton high school and approved 1006  
by the registrar. "Hamilton High School" license plates shall 1007

display county identification stickers that identify the county 1008  
of registration as required under section 4503.19 of the Revised 1009  
Code. 1010

(B) "Hamilton High School" license plates and a validation 1011  
sticker, or validation sticker alone, shall be issued upon 1012  
receipt of an application for registration of a motor vehicle 1013  
under this section; payment of the regular license tax as 1014  
prescribed under section 4503.04 of the Revised Code, any 1015  
applicable motor vehicle license tax levied under Chapter 4504. 1016  
of the Revised Code, any applicable additional fee prescribed by 1017  
section 4503.40 or 4503.42 of the Revised Code, an additional 1018  
administrative fee of ten dollars, and a contribution as 1019  
provided in division (C)(1) of this section; and compliance with 1020  
all other applicable laws relating to the registration of motor 1021  
vehicles. 1022

(C)(1) For each application for registration and 1023  
registration renewal notice the registrar receives under this 1024  
section, the registrar shall collect a contribution of thirty 1025  
dollars. The registrar shall deposit this contribution into the 1026  
state treasury to the credit of the license plate contribution 1027  
fund created in section 4501.21 of the Revised Code. 1028

(2) The registrar shall deposit the administrative fee of 1029  
ten dollars, the purpose of which is to compensate the bureau of 1030  
motor vehicles for additional services required in the issuing 1031  
of "Hamilton High School" license plates, into the state 1032  
treasury to the credit of the public safety - highway purposes 1033  
fund created in section 4501.06 of the Revised Code. 1034

**Sec. 4503.963.** (A) The owner or lessee of any passenger 1035  
car, noncommercial motor vehicle, recreational vehicle, or other 1036  
vehicle of a class approved by the registrar of motor vehicles 1037

may apply to the registrar for the registration of the vehicle 1038  
and issuance of "Ross High School" license plates. The 1039  
application may be combined with a request for a special 1040  
reserved license plate under section 4503.40 or 4503.42 of the 1041  
Revised Code. Upon receipt of the completed application and 1042  
compliance by the applicant with divisions (B) and (C) of this 1043  
section, the registrar shall issue to the applicant the 1044  
appropriate vehicle registration and a set of "Ross High School" 1045  
license plates and a validation sticker, or a validation sticker 1046  
alone when required by section 4503.191 of the Revised Code. 1047

In addition to the letters and numbers ordinarily 1048  
inscribed on the license plates, "Ross High School" license 1049  
plates shall display an appropriate logo and words that are 1050  
selected by representatives of Ross high school and approved by 1051  
the registrar. "Ross High School" license plates shall display 1052  
county identification stickers that identify the county of 1053  
registration as required under section 4503.19 of the Revised 1054  
Code. 1055

(B) "Ross High School" license plates and a validation 1056  
sticker, or validation sticker alone, shall be issued upon 1057  
receipt of an application for registration of a motor vehicle 1058  
under this section; payment of the regular license tax as 1059  
prescribed under section 4503.04 of the Revised Code, any 1060  
applicable motor vehicle license tax levied under Chapter 4504. 1061  
of the Revised Code, any applicable additional fee prescribed by 1062  
section 4503.40 or 4503.42 of the Revised Code, an additional 1063  
administrative fee of ten dollars, and a contribution as 1064  
provided in division (C) (1) of this section; and compliance with 1065  
all other applicable laws relating to the registration of motor 1066  
vehicles. 1067

(C) (1) For each application for registration and 1068  
registration renewal notice the registrar receives under this 1069  
section, the registrar shall collect a contribution of thirty 1070  
dollars. The registrar shall deposit this contribution into the 1071  
state treasury to the credit of the license plate contribution 1072  
fund created in section 4501.21 of the Revised Code. 1073

(2) The registrar shall deposit the administrative fee of 1074  
ten dollars, the purpose of which is to compensate the bureau of 1075  
motor vehicles for additional services required in the issuing 1076  
of "Ross High School" license plates, into the state treasury to 1077  
the credit of the public safety - highway purposes fund created 1078  
in section 4501.06 of the Revised Code. 1079

**Section 2.** That existing section 4501.21 of the Revised 1080  
Code is hereby repealed. 1081
