A BILL

To make operating appropriations for the Bureau of 1
Workers' Compensation for the period beginning 2
July 1, 2019, and ending July 31, 2019. 3

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. Within the limits set forth in this act, the 4
Director of Budget and Management shall establish accounts 5
indicating the source and amount of funds for each appropriation 6
made in this act, and shall determine the form and manner in 7
which appropriation accounts shall be maintained. 8

Section 2. (A) Except as provided in divisions (C) and (D) 9
of this section, there is hereby appropriated for the period 10
July 1, 2019, through July 31, 2019, out of money in the state 11
treasury to the credit of the respective funds of the state from 12
which appropriations were made for the 2019 fiscal year, for 13
each specific item for which an appropriation was made in Sub. 14
H.B. 27 of the 132nd General Assembly, taking into account 15
Controlling Board actions and executive budget reductions, an 16
amount equal to one-twelfth of each item's expenditure levels 17

for the 2019 fiscal year. 18

(B) No money shall be expended by the Bureau of Workers' 19
Compensation for any program that is new or to the extent it has 20
been expanded other than by operation of law. 21

(C) No money is appropriated for purposes that have full 22
fiscal year 2020 appropriations by another act of the General 23
Assembly. 24

(D) Where additional amounts are necessary to pay the 25
wages, benefits, and other payroll-related expenses of affected 26
state employees who are paid directly by warrant of the Director 27
of Budget and Management, those additional amounts are hereby 28
appropriated. 29

(E) The Director of Budget and Management shall make any 30
determinations necessary to decide which provision applies from 31
this section. 32

Section 3. All appropriations contained in this act shall 33
be cumulative with any subsequent appropriation act of the 133rd 34
General Assembly, and the Director of Budget and Management 35
shall account for expenditures from appropriations contained in 36
this act accordingly. 37

Section 4. Law contained in the main operating 38
appropriations act of the 133rd General Assembly that is 39
generally applicable to the appropriations made in the main 40
operating appropriations act also is generally applicable to the 41
appropriations made in this act. 42

Section 5. The sections of law contained in this act are 43
exempt from the referendum under Ohio Constitution, Article II, 44
Section 1d and section 1.471 of the Revised Code, and therefore 45
take effect immediately when this act becomes law. 46
