## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

ratification of the Amendment on June 16, 1919; and the thirty-sixth state ratification of the Amendment by the Tennessee General Assembly on August 18, 1920, the Women's Suffrage Centennial Commission shall plan and carry out events and activities throughout Ohio during the years 2019 and 2020. The events and activities shall honor the women's suffrage movement and shall raise awareness of, and educate the public about, the importance and historical significance of the Nineteenth Amendment. The Commission may enter into contracts and execute all instruments necessary or incidental to the performance of the Commission's duties under this section. 

- (D) There is in the state treasury the Women's Suffrage
  Centennial Commission Fund, which shall consist of any moneys
  appropriated or donated to the Fund and any interest earned on
  the moneys in the Fund. The Commission may solicit and accept
  grants, gifts, or donations from any lawful source and shall
  deposit all such grants, gifts, or donations in the state
  treasury to the credit of the Fund. The Commission shall use the
  moneys in the Fund for the purpose of carrying out the
  Commission's duties under this section.
- (E) The Women's Suffrage Centennial Commission shall cease to exist on December 31, 2020. On that date, any unencumbered, unobligated balance remaining in the Women's Suffrage Centennial Commission Fund shall be deposited in the General Revenue Fund. When no moneys remain in the Women's Suffrage Centennial Commission Fund, it shall cease to exist.
