**INTRODUCTION OF BILLS**

To amend section 4501.21 and to enact section 4503.509 of the Revised Code to create "The Ohio Aerospace Institute" license plate.

**H. B. No. 767** - Representative Perales.

To amend section 3321.191 of the Revised Code to specify that a child's absence due to a chronic medical condition that is acknowledged by the child's individualized education program or 504 plan is a medical excuse for purposes of absence intervention requirements.

**H. B. No. 768** - Representatives Boggs, Lightbody.

To enact section 5.2316 of the Revised Code to designate November 23rd as "Women and Girls in STEM Day."

**H. B. No. 769** - Representative Brinkman.

To enact section 5534.416 of the Revised Code to designate a portion of U.S. Route 50 in Hamilton County as the "Deputy Sheriff Emil Kleinwaechter Memorial Highway."

**H. B. No. 770** - Representatives Richardson, Fraizer.
