CORONAVIRUS LOCAL FISCAL RECOVERY

The foregoing appropriation item 042526, Coronavirus Local 14 Fiscal Recovery, shall be used by the Director of Budget and 15 Management to disburse funding to nonentitlement units of local 16 government in Ohio, including cities, villages, and townships, 17 on a population basis in accordance with the provisions of the 18 "American Rescue Plan Act of 2021," Pub. L. No. 117-2, and 19 consistent with guidance issued under that act. 20

Section 3. Within the limits set forth in this act, the 21 Director of Budget and Management shall establish accounts 22 23 indicating the source and amount of funds for each appropriation made in this act, and shall determine the form and manner in 24 which appropriation accounts shall be maintained. Expenditures 25 from operating appropriations contained in this act shall be 26 accounted for as though made in the main operating 27 appropriations act of the 134th General Assembly. The operating 28 appropriations made in this act are subject to all provisions of 29 the main operating appropriations act of the 134th General 30 Assembly that are generally applicable to such appropriations. 31
