Monday, January 4, 2021, 2:00 o'clock p.m.

This being the day designated by the Constitution of the State of Ohio for the meeting of the General Assembly in regular session, the members-elect of the House of Representatives assembled in the Hall of the Representatives at 2:00 o'clock p.m. and were called to order by the Honorable Robert R. Cupp, Speaker of the House of Representatives, One Hundred Thirty-Third General Assembly.

The One Hundred and Thirty-Fourth General Assembly rose for the opening prayer, offered by Representative-elect Gary Click, followed by the Pledge of Allegiance to the Flag.

Pursuant to Section 101.11 of the Ohio Revised Code, the Chair appointed Representative Hicks-Hudson to serve as clerk pro tempore.

The election of Speaker being in order, Representative Hoops of the 81st district nominated for the office of Speaker, Robert R. Cupp of the 4th district.

Representative Stephens of the 93rd district seconded the nomination.

Representative Stephens of the 93rd district moved that the nominations of Speaker be closed.

The motion was agreed to without objection.

The House then proceeded to the election of Speaker.

Having received a constitutional majority of all votes cast, Robert R. Cupp was declared the duly elected Speaker of the House of Representatives of the One Hundred Thirty-Fourth General Assembly of the State of Ohio.

Speaker Cupp was escorted by his wife, Libby, to the bar of the House.

Upon being presented, Speaker Cupp was administered the oath of office by The Honorable Patrick F. Fischer, Justice of the Ohio Supreme Court, and entered upon the discharge of his duties.

The Speaker then addressed the House as follows:

"First of all, let me say, 'Thank you.'

I am honored by the trust you have placed in me to lead this historic chamber for the One Hundred and Thirty Fourth General Assembly. I recognize that with trust comes responsibility. I will work hard for you to fulfill that responsibility --- and also with you to fulfill our mutual responsibilities to all Ohioans.

Great trust and responsibility is also what our constituents have placed in each of us, and which we have freely accepted by our oath and our actions.

Today we begin a new legislative session – an occasion filled with promise and possibility.

I thank Justice Fischer and Judge Hamilton for assisting today by administering the oaths of office during our session today.

Our program today is without some of the ceremony that usually accompanies the first day of a new legislative session. Because of the continuing spread of the novel coronavirus, we have exchanged much of the ceremonial extras for an extra measure of safety for members and staff. Some might call this a 'bare bones' proceeding, but I prefer to call it 'classic

simplicity.'

Serving in public life is not simple, and the effort that goes into being elected and serving in the legislature is not borne by members alone. Our spouses, family members or significant others are also affected by what we do. They often are called to sacrifice as well and the importance of their commitment to our task and our cause cannot be overstated.

For example, my wife, Libby, has done triple duty over the years: as an educator whose focus was on career and economic education, as a mother raising two Eagle Scout sons, and as my life's partner. I firmly believe she is what God knew I needed to serve out the calling He has placed upon my life throughout the years. She has been my greatest encourager, my most understanding consoler, my advisor, and when needed, a kindly critic. Thank you, Libby. I love you.

To our 20 new members, I am delighted to welcome you to the Ohio House of Representatives. Thank you for your commitment to serving the people of your district, as well as the people of our state, by engaging in the legislative process here in the People's House. There is no other experience that equates to that of serving as a state legislator. And, this is both a challenging, as well as exciting, time to be entering legislative service. I trust that it will be such a rewarding time that in future years you will count it as one of your life's most important experiences.

To our 79 returning members, including those whose service here has been separated by a span of years, I'm pleased to welcome you back as we convene the 134th General Assembly. Your experience, insights and knowledge of the House and the General Assembly are invaluable qualities and will serve us well in this new session. It is worth remembering that each session sets a new stage, mixes in new players, and features some new themes.

This great chamber echoes not just with our voices but with those who came before us, too. Like each of us, they sought to make Ohio a better place. Generation after generation, they tackled problems and balanced budgets. They had the vision to improve education, invest in our infrastructure and protect public safety and more. Their leadership has guided our state and served its people ever since the first session of the Ohio General Assembly convened in Chillicothe in 1803. Our work will add new perspectives and new ideas, and add a new chapter to the history of this great institution.

And if we do our work well, Ohio and its people will be better for it.

Among the common threads connecting all who have served in this chamber is a desire to engage in something larger than ourselves; to have a lasting impact that makes a positive difference in the lives of others. As Albert Einstein so aptly put it,

'There is no greater satisfaction for a just and well-meaning person than the knowledge that he has devoted his best energies to the service of the good cause.'

I know it is this 'sense of service' individually and collectively, that will enable this body to serve the people of Ohio well.

In 2020, Ohioans experienced unprecedented challenges touching virtually every aspect of their lives, triggered by a virus that, one year ago, few had heard of.

The impact of the pandemic is all around us, affecting not only physical and mental health, but also livelihoods and financial health, education and learning, social interactions, and other impacts we have yet to recognize or tally.

With this in mind, in this session of the General Assembly, we must continue working to assist in recovery, re-open our economy safely and fully, and rebuild a workable system of checks and balances for the future.

Throughout this pandemic, some remarkable Ohioans have worked tirelessly and without fanfare on the frontlines to help others when they needed it most...these health care professionals, first responders, members of law enforcement, members of the National Guard, teachers and dedicated and creative volunteers have served with great honor to help their fellow Ohioans.

To these heroes, we say, 'thank you.'

Throughout its history, the Ohio House of Representatives and its members have helped to lead our state in times of challenge and struggle and in times of prosperity and innovation.. That will certainly hold true again in 2021, not only in recovering from the devastating result of COVID-19 but also on a wide range of issues that are important for Ohio, its people and its future.

Our work will not be measured merely in the number of bills and resolutions we pass -- but more broadly in the opportunities we expand, the rights we protect and the lives that improve because of our efforts.

Our legacy will be found not only in what we accomplish today but also in the long-term effects that will only be evident years from now.

Government can't and shouldn't do everything, but what it does, it should do well -- and do so effectively and efficiently.

As a co-equal branch of government, the legislature has a critical policymaking and oversight role. The Ohio General Assembly makes the laws . . . that shape the policies . . . that solve problems confronting Ohio and Ohioans, and creates opportunity for all individuals to rise to their full

potential.

The People's House brings together individuals of deep and diverse experience to work together to replace problems with solutions.

Assembled here are those who have served our country in the armed forces or served our communities as members of law enforcement and as first responders. Our colleagues have taught in classrooms, served in local government, volunteered in local communities, worked with children and adults in need. Others have created jobs and met a payroll. Also assembled here are farmers, lawyers, healthcare professionals...and more. Our members range in age from the early 20s through the 70s. And, each have important contributions to make.

This extraordinary depth of knowledge and experience will be invaluable to the work of this House as we consider, weigh, develop, debate and pass proposed new legislation in the weeks and months ahead.

We will have a robust committee process that fosters meaningful debate and thoughtful legislation...with a single over-riding goal: good public policy that works for Ohioans.

We will work collaboratively to develop innovative solutions to complex problems.

It is natural in a body of 99 individuals, who come from or represent many walks of life, and who draw from many different life experiences, that there will be honest disagreements. Disagreements over what is or is not good public policy, the content of bills under consideration, how to spend the public's money appropriately, and more. That's part of the legislative process. But, I believe it's important to put these policy differences in context. It is possible to disagree without being disagreeable. To engage in policy discussions with civility and respect for the other's point of view. To build friendships and good relationships even while on opposite sides of issues . . . or of the aisle. And, when we achieve this, then opportunities to find mutual solutions to mutual problems will grow – and all of our constituents will be better served.

I look forward to the next two years, working with each of you...with integrity and determination...to accomplish important legislative tasks, to make good and beneficial laws and policies for the people of Ohio, to help create a bright future for our state, and to uphold the finest traditions of legislative achievement in this, the People's House.
