INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 141 - Representatives Skindell, Upchurch.

To make appropriations related to public transportation.

H. B. No. 142 - Representatives Crawley, Brinkman.

To enact sections 4723.89, 4723.90, 5120.658, and 5164.071 of the Revised Code regarding doula services and to repeal sections 4723.89, 4723.90, 5120.658, and 5164.071 of the Revised Code four years after those sections take effect, to abolish those provisions on that date.

H. B. No. 143 - Representative Hillyer.

To amend sections 122.65, 122.658, and 151.40 of the Revised Code relating to the Clean Ohio Program and to make an appropriation.

To amend sections 164.07, 307.022, 307.671, 307.673, 307.674, 307.696, 308.21, 351.06, 353.03, 1506.44, 1710.02, 4115.03, 4115.04, 4115.06, 5540.03, 6117.012, and 6121.061 of the Revised Code to allow political subdivisions, special districts, and state institutions of higher education to elect to apply the Prevailing Wage Law to public improvement projects.

H. B. No. 147 - Representatives Boggs, Lightbody.

To amend section 3313.666 of the Revised Code to require the Department of Education to develop a process for requesting an investigation of a school's compliance with its policy prohibiting harassment, intimidation, or bullying.

To amend section 3501.11 and to enact section 5.31 of the Revised Code to designate February 21 as "Congressman John Lewis Voter Registration Day" and to require the boards of elections to promote that day to encourage voter registration.

H. B. No. 149 - Representatives Swearingen, Stewart.

To amend sections 3501.01, 3505.03, 3505.04, and 3513.257 of the Revised Code to require certain judicial candidates to appear on the ballot with a party designation.

H. B. No. 150 - Representatives Hillyer, Leland.

To amend sections 5747.01 and 5747.10 and to enact sections 120.61, 120.62, 120.63, 120.64, 120.65, 120.66, 120.67, and 120.68 of the Revised Code to establish the Ohio Public Defender State Loan Repayment Program, to establish a task force to study Ohio's indigent defense system, and to make an appropriation.

H. B. No. 151 - Representative Jones.

To amend sections 3302.151, 3319.111, 3319.229, 3319.26, 3319.61, 3333.048, and 3333.39 of the Revised Code and to amend Section 4 of H.B.

442 of the 133rd General Assembly to replace the Ohio Teacher Residency program with local new teacher mentorship programs beginning with the 2023-2024 school year.

H. B. No. 152 - Representatives Stewart, Ginter.

To amend section 1509.28 of the Revised Code to revise the law governing unit operation.
