The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Richardson was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 158 - Representative Baldrige.

Cosponsors: Representatives Seitz, Smith, K., Ghanbari, Ray, Miller, J., Riedel, Abrams, Carruthers, Troy, Gross, Johnson, White, LaRe, Young, T., Jones.

To enact section 3737.52 of the Revised Code to prohibit the use of class B firefighting foam containing intentionally added PFAS chemicals for testing and training purposes.

H. B. No. 159 - Representatives Hillyer, Lightbody.

Cosponsors: Representatives Leland, Liston, Ginter, Russo, Smith, K., Seitz, Weinstein, Miller, A.

To amend sections 4713.50, 4713.51, and 4713.64 of the Revised Code to prohibit the provision of sun lamp tanning services to individuals under age 18.

H. B. No. 160 - Representative Holmes.

Cosponsors: Representatives Click, Gross, Jones, Lanese, Loychik, Riedel, Stein, McClain, Zeltwanger.

To enact sections 3962.01, 3962.011, 3962.02, 3962.03, 3962.04, 3962.05, 3962.06, 3962.07, 3962.08, 3962.09, 3962.10, 3962.11, 3962.111, 3962.12, 3962.13, 3962.14, 3962.15, 5162.801, and 5164.65 of the Revised Code regarding the provision of health care cost estimates.

H. B. No. 161 - Representative Lampton.

Cosponsors: Representatives Lipps, Ray, Merrin, Ginter, Ghanbari, Young, T., Riedel, Click.

To amend section 2903.41 of the Revised Code to include certain child abuse-related offenses in the violent offender database and to name the act Jacob's Law.

H. B. No. 162 - Representative Galonski.

To express the General Assembly's intent to remove from the Revised Code derogatory terminology regarding individuals with disabilities.

H. B. No. 163 - Representatives Cutrona, Sweeney.

Cosponsors: Representatives Riedel, Gross, Jones, Miller, J., Carruthers, O'Brien.

To amend section 3727.53 and to enact section 3727.58 of the Revised Code to prohibit a hospital from requiring a nurse to work overtime as a condition of continued employment.

H. B. No. 164 - Representative Ghanbari.

To enact section 5534.837 of the Revised Code to designate a portion of State Route 795 in Wood County as the "Lake Township Veterans Memorial Highway."

H. B. No. 165 - Representative McClain.

Cosponsors: Representatives Click, Koehler, Hoops, Johnson, Weinstein, Ghanbari, Lipps, Carfagna, Riedel, Creech, Miller, J., Manchester, Richardson.

To amend sections 5747.98 and 5751.98 and to enact sections 5747.74 and 5751.55 of the Revised Code to temporarily authorize a nonrefundable tax credit for the retail sale of high-ethanol blend motor fuel.

H. B. No. 166 - Representatives Boggs, Carfagna.

Cosponsors: Representatives Russo, Leland, Brown, Ghanbari, O'Brien, Sweeney, Seitz, Weinstein, Lightbody, Gross, Smith, K., Young, T., Liston, Plummer, Miranda, Galonski, Crossman, Crawley, Miller, J., Sheehy.

To amend sections 181.21, 2152.13, 2152.14, 2901.011, 2929.01, 2929.14, 2929.144, 2929.19, 2929.20, 2930.16, 2945.37, 2945.401, 2949.08, 2951.03, 2953.07, 2953.08, 2967.14, 2967.191, 2967.193, 2967.271, 5120.021, 5120.038, 5120.113, 5120.66, and 5149.04 and to enact section 181.26 of the Revised Code to modify the Criminal Sentencing Law with respect to non-life felony indefinite sentencing, to modify the process for felony appeals as a matter of right, to modify the Corrections Law regarding a Department of Rehabilitation and Correction reentry program for certain offenders, maximum workload and caseload standards for parole and field officers, GPS monitoring of offenders released from prison, and entry into LEADS of specified information about GPS-monitored offenders, and to require the Ohio Criminal Sentencing Commission to appoint an Offender Supervision Study Committee.

H. B. No. 167 - Representative Oelslager.

To provide rent and utility assistance and to make an appropriation.

H. B. No. 168 - Representatives Fraizer, Loychik.

To provide grants to businesses, local fairs, child care providers, and veterans homes and to make an appropriation.

H. B. No. 169 - Representatives Cutrona, Swearingen.

To provide grants to bars and restaurants and the lodging industry and to make an appropriation.

H. B. No. 170 - Representatives Bird, Richardson.

To provide assistance to schools and other entities in response to the COVID-19 pandemic and to make an appropriation.

Said bills were considered the first time.
