To amend sections 5747.08 and 5747.98 and to enact section 5747.77 of the Revised Code to authorize a nonrefundable income tax credit for contributions to certain charitable organizations.

To enact section 5534.414 of the Revised Code to designate a portion of State Route 32 in Clermont County as the "Deputy Bill Brewer Memorial Highway."

To amend section 5302.30 and to enact section 3723.30 of the Revised Code to require the Director of Health to establish an indoor mold program.

H. B. No. 252 - Representatives White, Plummer.

To enact sections 4753.17 and 4753.171 of the Revised Code to enter into the Audiology and Speech-Language Pathology Interstate Compact.

H. B. No. 253 - Representative Cutrona.

To enact section 3792.02 of the Revised Code regarding proof of COVID-

19 vaccinations.
