#### **INTRODUCTION OF BILLS**

To amend sections 5747.08 and 5747.98 and to enact sections 2923.191 and 5747.72 of the Revised Code to enact the Child Access Prevention Tax Credit Act to prohibit negligent storage of a firearm, to provide criminal penalties if a minor gains access to an improperly stored firearm, and to authorize an income tax credit for the purchase of firearms safety storage units.

H. B. No. 263 - Representative Roemer.

To enact section 5534.605 of the Revised Code to designate a portion of County Road 321 in Stark County as the "Sgt. Vernon R. Judd Memorial Highway."

**H. B. No. 264 -** Representatives Smith, M., Sobecki. Cosponsors: Representatives Leland, Miranda, Galonski, Sweeney, Skindell, Denson, Crawley, Howse, Miller, A., Lepore-Hagan, Blackshear, Sheehy, Weinstein, Brown.

To amend Section 29 of H.B. 197 of the 133rd General Assembly to modify the municipal income tax withholding rule for employees working at a temporary worksite.
