- (6) On a quarterly basis, prepare a report outlining best practices and new developments related to drug use prevention and treatment, post the report to the governor's web site, provide copies to local boards of health, and submit a copy to the general assembly in accordance with section 101.68 of the Revised Code;
- (7) Establish a telephone hotline to assist individuals and local communities in preventing and reducing drug misuse, addiction, and overdose deaths;
- (8) On a quarterly basis, organize and hold a meeting of state and local officials to discuss efforts to prevent and reduce drug misuse, addiction, and overdose death:
- (9) Establish a database of federal, state, and local resources available for drug use prevention and treatment, allow the public to access information maintained in the database, including from the governor's web site, and notify callers to the telephone hotline of the database;
- (10) Conduct outreach activities, including through television, radio, and other media, to inform the public of drug-related efforts by state agencies and local governments.

The office of drug policy may take any other action it considers necessary to implement this section.

(B) The governor shall appoint an executive director and as necessary other staff to manage the office and perform its duties."
