**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 369** - Representative Weinstein.

Cosponsors: Representatives Crossman, Galonski, Lepore-Hagan, Liston, Miller, A., Miller, J., Robinson, Skindell, Sobecki, Troy, Upchurch, West.

To amend section 3735.67 and to enact section 3735.674 of the Revised Code to enact the School Board Fairness Act, requiring school districts to approve certain residential community reinvestment area property tax exemptions.

**H. B. No. 370** - Representative Bird.

Cosponsors: Representatives White, Gross, Riedel, Johnson, Jones, Koehler.

To amend sections 3314.03, 3326.11, and 3328.24 and to enact section 3313.7117 of the Revised Code to enact the "Seizure Safe Schools Act" to require public and chartered nonpublic schools to create a seizure action plan for each student with a seizure disorder.

**H. B. No. 371** - Representatives Schmidt, Denson.

Cosponsors: Representatives Galonski, Troy, Weinstein, Miller, J., Ingram, Creech, Abrams, Pavliga, White, Miranda, O'Brien, Bird, Miller, K., Ghanbari, Young, T., Hoops, Lampton, John.

To amend sections 1751.62, 3702.40, 3923.52, 3923.53, and 5164.08 of the Revised Code to revise the laws governing coverage of screening mammography and patient notice of dense breast tissue.

**H. B. No. 372** - Representatives Ray, Roemer.

Cosponsors: Representatives Johnson, Click.

To amend sections 3781.19 and 3781.20 and to enact section 3781.21 of the Revised Code to make changes to the law relating to building inspections.
