#### **INTRODUCTION OF BILLS**

The following bills were introduced:

H. B. No. 384 - Representative Cutrona.

To enact section 5534.921 of the Revised Code to designate a portion of State Route 7 in Mahoning County as the "Clarence "Sonny" Smith, Jr. Highway."

H. B. No. 385 - Representative Cross.

Cosponsors: Representatives Creech, Click, Miller, J., Stoltzfus, Fowler Arthur.

To amend sections 6111.04 and 6111.99 and to enact section 6111.61 of the Revised Code to prohibit a municipal corporation located within the Western Basin of Lake Erie from discharging any amount of waste into Ohio waters.

Said bills were considered the first time.
