#### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 386** - Representatives Ingram, Hicks-Hudson. Cosponsors: Representatives Brent, Crossman, Denson, Howse, Miller, A., Miller, J., Sheehy, Smith, K., West.

To amend sections 9.481, 9.61, 737.08, and 737.22 of the Revised Code to allow a municipal corporation to require its fire chief or chief of police to reside within the municipal corporation during the chief's first five years.

#### H. B. No. 387 - Representative Dean.

To amend sections 3501.01, 3501.05, 3501.11, 3501.22, 3503.10, 3503.11, 3503.14, 3503.16, 3503.19, 3503.20, 3503.28, 3505.08, 3505.18, 3505.181, 3505.182, 3505.183, 3506.05, 3506.07, 3506.10, 3506.14, 3506.21, 3506.23, 3509.01, 3509.02, 3509.03, 3509.04, 3509.05, 3509.051, 3509.06, 3509.07, 3509.08, 3509.09, 3509.10, 3511.02, 3511.04, 3511.05, 3511.06, 3511.07, 3511.08, 3511.09, 3511.10, 3511.11, 3511.13, 3599.27, 4507.50, 4507.501, 4507.51, and 4507.52; to enact sections 3506.17, 3509.031, 4507.41, and 4507.502; and to repeal section 111.31 of the Revised Code to make changes to the Election Law.

To enact section 3792.05 of the Revised Code to prohibit taking certain actions against an individual because the individual refuses to be vaccinated against a disease.

#### H. B. No. 389 - Representatives Leland, Seitz.

Cosponsors: Representatives Hoops, Ray, Stein, Lightbody, Boggs, Wilkin, Ingram, Sweeney, Brinkman, Carfagna, Gross, Hillyer.

To amend section 4928.02 and to enact sections 4928.6630, 4928.6631, 4928.6633, 4928.6634, 4928.6636, 4928.6639, 4928.6641, 4928.6644, 4928.6646, 4928.6647, 4928.6650, 4928.6653, 4928.6655, 4928.6657, and 4928.6660 of the Revised Code to permit electric distribution utilities to establish energy efficiency and peak demand reduction portfolios.
