The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 390 - Representatives Lanese, John.

Cosponsors: Representatives Bird, Click, Carfagna, Ferguson, Fowler Arthur, Gross, Hall, Koehler, Ray, Richardson, Schmidt, White.

To amend section 2933.82 of the Revised Code to require governmental evidence-retention entities to secure and test sexual assault examination kits in relation to an investigation or prosecution of trafficking in persons.

H. B. No. 391 - Representatives Miller, A., Galonski.

To enact section 109.661 of the Revised Code to create the anti-prostitution grant program fund and to make an appropriation.

H. B. No. 392 - Representatives Ferguson, Miller, K.

Cosponsors: Representatives Carruthers, Ghanbari, Hillyer, Click, Riedel, Seitz, Fowler Arthur, Lampton, LaRe, Hoops, Hall, Cross, Schmidt, Plummer.

To amend section 4765.52 of the Revised Code to authorize ambulance transport of an injured police dog when the dog is injured in the line of duty.

H. B. No. 393 - Representative Click.

Cosponsors: Representatives Bird, Ghanbari, Gross, John, Pavliga, Riedel, Schmidt, Young, T.

To enact section 5534.889 of the Revised Code to designate a portion of State Route 19 in Sandusky county as the "Teresa M. Martin 9/11 Memorial Highway."

H. B. No. 394 - Representative Carruthers.

To amend section 4501.21 and to enact section 4503.885 of the Revised Code to create the "Stephen T. Badin High School" license plate.

H. B. No. 395 - Representative Powell.

To enact section 5534.416 of the Revised Code to designate a portion of I-75 in Miami County as the "Ohio State Highway Patrol MCEI Kimra Skelton

Memorial Highway."

H. B. No. 396 - Representatives Smith, K., Smith, M.

Cosponsors: Representatives Crossman, Galonski, Miranda, O'Brien.

To enact sections 4145.01, 4145.02, 4145.03, 4145.04, 4145.05, and 4145.06 of the Revised Code to create the fair paycheck workplace certificate.

Said bills were considered the first time.
