INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 397 - Representatives Stewart, Kick.

Cosponsors: Representatives Bird, Click, Creech, Hall, John, Johnson, Lanese, Miller, J., Plummer, Riedel, Swearingen, West, Young, T.

To enact section 5301.71 of the Revised Code to revise the law regarding agricultural leases.

H. B. No. 398 - Representatives Brown, Sweeney.

Cosponsors: Representatives Blackshear, Boggs, Crossman, Galonski, Howse, Ingram, Jarrells, Kelly, Miller, J., Miranda, O'Brien, Robinson, Russo, Sheehy, Smith, K., Weinstein.

To award a one-time bonus to eligible service members of the Ohio National Guard and the Ohio State Defense Force, to name the act the Democracy Bonus Act, and to make an appropriation.

H. B. No. 399 - Representatives Smith, K., Callender.

Cosponsors: Representatives Boyd, Galonski, O'Brien.

To amend section 5747.98 and to enact sections 122.851 and 5747.67 of the Revised Code to temporarily authorize a refundable income tax credit for investing in a sound recording production company.

H. B. No. 400 - Representatives Loychik, Schmidt.

To amend sections 3313.665, 3314.03, 3326.11, and 3328.24 and to enact section 3313.7117 of the Revised Code to prohibit public schools from requiring students to wear a mask or other facial covering on school premises or a school bus and to declare an emergency.

H. B. No. 401 - Representative Edwards.

To amend section 4123.01 and to enact section 4113.65 of the Revised Code to exempt an injury or disability caused by an employer-mandated COVID-19 vaccination from the Workers' Compensation Law and to allow the employee to sue the employer for damages.

H. B. No. 402 - Representatives Boyd, Hicks-Hudson.

To amend sections 1739.05, 4723.01, 4729.01, and 4729.541; to enact sections 1751.671, 3923.631, 3923.641, 4754.01, 4754.02, 4754.03, 4754.04, 4754.05, 4754.06, 4754.07, 4754.08, 4754.09, 4754.10, 4754.11, 4754.12, 4754.13, 4754.14, 4754.141, 4754.142, 4754.15, 4754.16, 4754.17, 4754.99, and 5164.072; and to repeal section 4723.45 of the Revised Code to regulate the practice of certified professional midwives and to name this act the Ohio Midwife Practice Act.

Said bills were considered the first time.
