The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Stewart was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 423 - Representatives Roemer, Young, B.

Cosponsors: Representatives Bird, Click, Riedel.

To enact section 5.076 of the Revised Code to designate the All-American Soap Box Derby as the official state gravity racing program.

H. B. No. 424 - Representative Koehler.

To amend section 2305.2311 and to enact sections 2305.2312 and 3792.05 of the Revised Code to prohibit a political subdivision, public official, public school, state agency, or state institution of higher education from taking certain actions related to the COVID-19 vaccine, to codify the qualified civil immunities under H.B. 606 of the 133rd General Assembly permanently, to repeal section 3792.05 of the Revised Code on the date that is two years after the effective date of that section, and to declare an emergency.

H. B. No. 425 - Representatives Wiggam, Hall.

To enact section 3792.02 of the Revised Code to prohibit certain actions related to COVID-19 and genetic technologies.

H. B. No. 426 - Representative Brown.

Cosponsors: Representatives O'Brien, Crossman, Smith, K., Troy, Weinstein, Sobecki, Lightbody, Miller, J., Galonski, Sheehy.

To amend sections 755.13, 3313.5310, 3313.6021, 3313.6023, 3313.717, 3314.16, 3326.11, 3328.24, 3701.85, and 3707.58 and to enact section 3701.851 of the Revised Code to require the placement of automatic external defibrillators in each public and chartered nonpublic school and each public recreational facility and to require the Ohio Department of Health to develop a model emergency action plan for the use of automated external defibrillators.

H. B. No. 427 - Representatives White, Manchester.

Cosponsors: Representatives Plummer, LaRe, Carfagna, Loychik, Young, T., Click, Koehler, Schmidt, John, Lanese, Riedel, Bird, Manning, Holmes, Johnson, Fowler Arthur, Richardson, Cutrona, Gross, Troy.

To amend sections 2905.32 and 2907.21 of the Revised Code to prohibit the use of a controlled substance or manipulation of controlled substance addiction as a method of human trafficking or to compel prostitution.

H. B. No. 428 - Representatives Pavliga, Edwards.

Cosponsors: Representatives Click, Grendell, Holmes, Plummer, White.

To enact sections 103.55, 103.551, and 103.552 of the Revised Code to establish the Adverse Childhood Experiences Study Commission.

Said bills were considered the first time.
