The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Richardson was selected to preside under the Rule.

The journal of yesterday was read and approved.

INTRODUCTION OF BILLS

The following bill was introduced:

H. B. No. 436 - Representatives Jordan, Carfagna. Cosponsors: Representatives Gross, Hall, Baldridge, Stephens, Miller, J., Johnson.

To amend sections 4582.06 and 5739.02 of the Revised Code to narrow the purposes for which a port authority that was created prior to July 9, 1982, may issue revenue bonds beyond the limit of bonded indebtedness and to exempt from sales and use tax sales of tangible personal property or services used in fulfilling a public contract with a port authority.

Said bill was considered the first time.

REPORTS OF STANDING AND SELECT COMMITTEES AND BILLS FOR SECOND CONSIDERATION

Representative O'Brien submitted the following report:

The standing committee on Agriculture and Conservation to which was referred **H. B. No. 175-**Representative Hillyer, et al., having had the same under consideration, reports it back with the following amendments and recommends its passage when so amended.

RE: DEREGULATE CERTAIN EPHEMERAL WATER FEATURES

Representative Creech moved to amend the title as follows:

Add the names: "Creech, Fowler Arthur, Jones"

Representative Creech moved to amend as follows:

In line 62, after "." insert "<u>"Ephemeral feature" does not include a</u> wetland as defined in section 6111.02 of the Revised Code."

In line 187, after "<u>snow.</u>" insert "<u>"Ephemeral feature" does not</u> include a wetland, as defined in section 6111.02 of the Revised Code." The motion was agreed to and the bill so amended.

Representative Creech moved to amend as follows:

In line 1 of the title, after "6111.01" insert "and to enact section 6111.011"

In line 5, after "6111.01" insert "be amended and section 6111.011" In line 6, delete "amended" and insert "enacted"

After line 187, insert:

"Sec. 6111.011. (A) The exclusion of ephemeral features from the definition of waters of the state under section 6111.01 of the Revised Code does not affect the director of environmental protection's authority to do all of the following:

(1) Administer and enforce Chapter 3734. of the Revised Code with regard to any discharge, deposit, dumping, or placement of wastes regulated under that chapter in an ephemeral feature;

(2) Administer and enforce Chapter 3714. of the Revised Code with regard to any discharge, deposit, dumping, or placement of construction and demolition debris in an ephemeral feature;

(3) Take any other authorized actions under the Revised Code, other than Chapter 6111. of the Revised Code, that apply to the discharge, deposit, dumping, or placement of waste, debris, or other materials in an ephemeral feature.

(B) The exclusion of ephemeral features from the definition of waters of the state under section 6111.01 of the Revised Code does not affect the authority of any state agency, other than the environmental protection agency, to take any authorized actions under the Revised Code, other than Chapter 6111. of the Revised Code, that apply to the discharge, deposit, dumping, or placement of waste, debris, or other materials in an ephemeral feature."

The motion was agreed to and the bill so amended.
